DIVISION OF INVESTMENT MANAGEMENT STAFF STATEMENT REGARDING WITHDRAWAL OF STAFF LETTERS RELATED TO RULEMAKING ON FUND OF FUNDS ARRANGEMENTS

On October 7, 2020, the Commission adopted rule 12d1-4 under the Investment Company Act to streamline and enhance the regulatory framework applicable to funds that invest in other funds.¹ Consistent with the adopted rule and the discussion in the related release, the staff is withdrawing the staff letters listed in Appendix A herein, effective as of the dates noted.
