Each of the issuers below either confirmed they were now private companies or no longer in operation, or failed to respond to the staff's inquiry about their operating status, did not have an operational address, or failed to provide their registered agent with an operational address. The staff of the Securities and Exchange Commission also determined that none of the issuers below has posted any information with OTC Markets Group, Inc. or filed any information with the Securities and Exchange Commission for the past two years.

* Below are explanations for each of the codes used in the above table:

1 = The staff of the Securities and Exchange Commission attempted to contact the issuer and either the staff did not receive a response to its letter, the letters were returned as undeliverable, or the registered agent responded that it had no forwarding address for the issuer.

2 = The staff of the Securities and Exchange Commission was able to contact the issuer, which informed the staff that it was now a private company.

3 = The staff of the Securities and Exchange Commission was able to contact the issuer, which informed the staff that it was no longer operating.

The Commission is of the opinion that the public interest and the protection of investors require a suspension of trading in the securities of the above-listed companies.

THEREFORE, IT IS ORDERED, pursuant to Section 12(k) of the Securities Exchange Act of 1934, that trading in the securities of the above-listed companies is suspended for the period from 9:30 a.m. EDT on April 10, 2017, through 11:59 p.m. EDT on April 24, 2017.
