COMMISSION ANNOUNCEMENTS

NOTIFICATION OF DELETION OF PRIVACY ACT SYSTEMS OF RECORDS

In accordance with the Privacy Act of 1974, 5 U.S.C. 552a, the Securities and Exchange Commission is deleting two records systems that were replaced by another existing system, and altering the notices of four existing systems of records to reflect revisions to the agency's address, deletion of references to the Civil Service Commission, updating the names of records systems and designating a new systems manager. ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS AGAINST ROBERT DOWD

The Commission announced that on April 8 it instituted public administrative proceedings against Robert I. Dowd (Dowd) and simultaneously accepted Dowd's Offer of Settlement. The Commission found that on March 10, 1992 Dowd was enjoined from future violations of the registration and antifraud provisions of the federal securities laws in SEC v. Robert I. Dowd, Civil Action No. 3:91 CV00561 TEC. The Commission's complaint alleged that Dowd defrauded advisory clients and facilitated an unregistered distribution of securities. The Commission's Order bars Dowd from association with any broker, dealer, municipal securities dealer, investment adviser or investment company, with a right to reapply in a non-supervisory capacity after four years. INVESTMENT COMPANY ACT RELEASES

ML VENTURE PARTNERS II, L.P., ET AL.

A notice has been issued giving interested persons until May 8 to request a hearing on an application filed by ML Venture Partners II, L.P., et al. for an order under Section 57(i) of the Investment Company Act and Rule 17d-1 thereunder. The order would authorize transactions which are otherwise prohibited under Section 57(a)(4) of the Act. The application also seeks an order under Section 57(c) exempting applicants from Section 57(a)(1) of the Act. Finally, the application seeks under Section 6(c) of the Act to amend a prior order of the Commission. The exemptions would permit certain applicants to engage in co-investments and joint transactions that otherwise would be prohibited. (Rel. IC-18652 - April 13)
