1. Please substantially revise this section to provide an accurate overview of your business as it is today. Refer to Item 503(a) of Regulation S-B. For example, highlight that while 94% of your revenue for the fiscal year ended 2006 came from gaming, you had no gaming revenue during the most recent interim period due to the passage of the United States Unlawful Internet Gambling Enforcement Act of 2006. As such, discuss what it is your business does now to generate

revenues. Also, include your revenues and net income or loss for the last audited period and interim stub.

Selling Shareholders, page 14

- 2. Please reconcile the total number of shares being registered according to the table in this section (9,200,000) with the number of shares being registered on the cover and elsewhere throughout the registration statement (9,000,000).
- 3. Also reconcile the number of shares owned prior to the offering according to the table in this section with the number of shares owned by the selling shareholders according to the beneficial ownership table and its footnotes on page 27.

• the company may not assert staff comments and the declaration of effectiveness as a defense in any proceeding initiated by the Commission or any person under the federal securities laws of the United States.

We will consider a written request for acceleration of the effective date of the registration statement as confirmation of the fact that those requesting acceleration are aware of their respective responsibilities under the Securities Act of 1933 and the Securities Exchange Act of 1934 as they relate to the proposed public offering of the securities specified in the above registration statement. We will act on the request and, pursuant to delegated authority, grant acceleration of the effective date.

We direct your attention to Rules 460 and 461 regarding requesting acceleration of a registration statement. Please allow adequate time after the filing of any amendment for further review before submitting a request for acceleration. Please provide this request at least two business days in advance of the requested effective date.
