Form S-3 filed June 26, 2020

General

1. We note that you are not eligible to conduct this offering on Form S-3 because you do not meet the conditions outlined in General Instruction I.A.3 or I.A.6 of Form S-3. In this regard, Zafgen, Inc. was the "acquired" company for financial reporting purposes in the business combination that closed on May 28, 2020 and the financial statements of Chondrial Therapeutics, Inc. have not been included in materials required to be filed pursuant to Section 13, 14 and 15(d) for a period of at least twelve calendar months immediately preceding the filing of the registration statement on Form S-3. Accordingly, please register the offering on Form S-1.
