Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Lightning's mission is to build world-class, two-wheel electric transportation with superior efficiency, performance, and affordability to current gasoline alternatives. The first challenge was to develop technology that is equal to or better than gasoline-powered motorcycles. Lightning seeks opportunities to compete to develop and prove our technology and has established our dominance by winning the first North American Electric motorcycle road racing championship. Later, Lightning set the land speed record at 215.960 mph (top speed of 218.637 mph) and became one of the world's fastest production electric motorcycles. We successfully created the Lightning EV technology platform to build electric motorcycles based on solutions that we developed. Next Lightning integrated race-proven technologies into our customer products – the Lightning LS-218 and the Lightning Strike Carbon which were well received by the market. Lightning's R&D team is working on 3 other products that will enable Lightning to enter into different motorcycle product segments and target to increase company revenue. Lightning plans to expand US operations to capture market demand, with the goal of reducing costs and increasing profitability.

Lightning Motorcycle currently has 15 employees.

Risk Factors

7. Material factors that make an investment in Lightning Motors Corporation speculative or risky:

1. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas,

and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.

- 2. The Company may never receive a future equity financing, or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). If a liquidity event does not occur, such as a sale of the Company or an IPO, the purchasers could be left holding Company securities in perpetuity. The Company's securities have numerous transfer restrictions and will likely be highly illiquid, with potentially no secondary market on which to sell them. The securities have only a minority of voting rights and do not provide the ability to direct the Company or its actions.
- 3. In order to expand, the Company is raising funds, and may raise additional funds in the future, either by offerings of securities or through borrowing from banks or other sources. The terms of future capital raising, such as loan agreements, may include covenants that give creditors greater rights over the financial resources of the Company.
- 4. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
- 5. Potential customers may be less willing to invest in innovation and forward-looking improvements if they are facing an economic downturn. This may temporarily reduce our market size. Furthermore, a global crisis might make it harder to diversify.
- 6. The Company may extend the Offering deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the maximum offering amount even after the Offering deadline stated herein is reached. Your investment will not be accruing interest during this time and will simply be held until such time that Offering is closed, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you.
- 7. No governmental agency has reviewed the Company's offering and no state or federal agency has passed upon either the adequacy of the disclosure contained herein or the fairness of the terms of this offering.
- 8. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
- 9. The Company does not anticipate paying any cash dividends for the foreseeable future. The Company currently intends to retain future earnings, if any, for the foreseeable future, to repay indebtedness and to support its business. The Company does not intend in the foreseeable future to pay any dividends to holders of its shares of common stock.
- 10. The failure to attract and retain key employees could hurt our business, and our management does not have extensive experience in the operation of businesses such as ours. Our success also depends upon our ability to attract and retain numerous highly qualified employees. Our failure to attract and retain skilled management and employees may prevent or delay us from pursuing certain opportunities. If we fail to successfully fill many management roles, fail to fully integrate new members of our management team, lose the services of key personnel, or fail to attract additional qualified personnel, it will be significantly more difficult for us to achieve our growth strategies and success.
- 11. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain

- skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 12. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

19. The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

- 22. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

- 24. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Lightning Motors Corporation ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. 10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Lightning Motors Corporation must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). The Company was organized on September 10, 2007 under the laws of Delaware. Our mission is to build world-class, two-wheel electric transportation with superior efficiency, performance, and affordability to current gasoline alternatives. Under the Company's articles of incorporation, the total number of shares the Company shall have the authority to issue is 11 million shares of common stock and 5 million shares of preferred stock. 2,200,000 shares of preferred stock have been designated "series A preferred stock", and 1,709,694 shares of preferred stock have been designated "series B preferred stock". As of the date of the filing of this offering, 4,425,882 shares of common stock are issued and outstanding, 2,200,000 shares of series A preferred stock are issued and outstanding, and 494,277 shares of series B preferred stock are issued and outstanding. During the year ended 2022, the Company generated approximately \$498,000 in revenue. The Company also raised an additional \$1 million through the issuance of a convertible note to a shareholder. During the year ended 2021, net revenue amounted to \$418,405, while the cost of goods sold was \$494,132. Additionally, the Company recorded an operating loss of \$455,844 and a net loss of \$354,021. During the same fiscal year, the Company raised \$149,000 through the issuance of convertible notes and \$45,000 from the issuance of related party promissory notes. Total convertible notes payable for the year ended 2021 amounted to \$1,259,000. Total related party promissory notes were \$1,036,500 during this period. On February 2, 2021, the Company entered into the Paycheck Protection Program ("PPP Loan"), with Citi Bank as the lender, in an aggregate principal amount of \$165,700. The PPP Loan was evidenced by a promissory note. During the year ended December 31, 2021, the Company recognized a total gain on forgiveness of debt of \$296,636, which included \$122,532 in forgiveness of this PPP Loan forgiveness. As of the date of the filing of this offering, the balance of the PPP Loan is \$43,168. During the year ended 2020, net revenue amounted to \$223,878, while the cost of goods sold was \$462,306. Additionally, the Company recorded an operating loss of \$827,197 and a net loss of \$1,189,191. During the same fiscal year, the Company raised \$100,000 through the issuance of convertible notes and \$95,000 through the issuance of related party promissory notes. Total convertible notes payable as of December 31, 2020 amounted to \$1,110,000 and total related party promissory notes were \$991,500. On May 1, 2020, the Company entered into the Paycheck Protection Program, with Citi Bank as the lender, and borrowed an aggregate principal amount of \$165,700, which was forgiven in its entirety during the year ended December 31, 2021. As of the date of the filing of this offering, the balance of this May 1, 2020 loan is \$0. On May 20, 2020, the Company received a \$150,000 Economic Injury Disaster Loan ("EIDL Loan") from the US Small Business Administration. As of the date of the filing of this offering, the outstanding balance of the EIDL Loan is \$150,000. With this raise, the Company plans to use the proceeds primarily for upscaling production and inventory, expanding the team, tooling expenses, sales and marketing, and professional services.
