Phase 1:

Phase 2:

- **USD \$2.00** per share for up to 485,000 shares (*maximum of USD \$970,000 in aggregate investments*)
- Pre-money valuation
 - Basic: USD \$4,063,078
 - Fully diluted: USD \$4,963,078
- Class of shares issued: **Non-voting common stock**
- For investments of USD \$10,000 or more, but less than USD \$20,000, issuing:
 - 1 Warrant** to purchase, within 5 years, 1 share of Non-Voting common stock at USD \$2.00
- For investments of USD \$20,000 or more, issuing:
 - 2 Warrant** to purchase, within 5 years, 1 share of Non-Voting common stock at USD \$2.00
- For investments of equal or more than USD \$50,000:
 - Class of shares issued: **Voting common stock**
