Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

GoPetie is a B2B and B2C mobile platform that connects pet owners to each other, to local service providers and to town/cities in a social mobile community environment. The GoPetie mobile app is a multiservice platform and social community where pet parents can connect to each other, find services and solutions for their daily problems. Service providers can connect and understand their consumers and manage their businesses effectively. In addition, GoPetie has developed the Pet Licensing Management System (PLMS), which is a patented technology to manage pet licenses. The PLMS will be used by municipalities to manage and process new licenses, renewals, transfers and confirm pet licenses. The PLMS optimizes and improves executional efficiency offering convenience and value for both, pet owners and municipalities. In addition, GoPetie has created a proprietary adoption process/system through the app to control adoption process and pet ownership. GoPetie anticipates it will have four revenue channels:

Risk Factors

7. Material factors that make an investment in Pet & Tie, Inc. speculative or risky:

1. We are raising seed funding to finish the development of the mobile app and the PLMS. The risk associated with investing in an early is similar to investing in any other early state startups. However, we believe we have a huge potential because we are going into a \$69 billion dollar market, which is growing every year.
2. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if he fails to perform in his current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business.
3. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.
4. Start-up investing is risky. Investing in startups is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. 6. Third parties might infringe upon our technology. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
7. We have a limited operating history upon which investors may base an evaluation of our potential future performance. In particular, we have not proven that we can develop and maintain relationships with key vendors and strategic partners to extract value from our intellectual property, raise sufficient capital in the public and/or private markets, or respond effectively to competitive pressures. As a result, there can be no assurance that we will be able to develop or maintain consistent revenue sources, or that our operations will be profitable and/or generate positive cash flows
8. In April 2018 we acquired pet licensing software from an operating business, including 39 municipal customers. Please refer to the description of this software in item #31 below. There is a risk that we will not be able to successfully integrate this customer base into our PLMS software. Additionally, there is a risk that we will not be able to retain some or all of the 39 municipal customers.

The Offering

Pet & Tie, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$105,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

We anticipate the funds will be used as follows: Complete the PLMS and integrate with the new GoPetie app. Hire 1 sales person to sell the PLMS and the GoPetie business platform. Buy laptops and other sales tools. Complete PLMS pilot in three municipalities in MA. Launch PLMS and GoPetie in Canada. Implement PLMS in other 40 municipalities in Massachusetts. Reach 1 million followers on Facebook and Instagram. Acquire 215,000 users (U.S and Canada). Hire 4 sales people to sell the PLMS and the GoPetie business platform. Launch PLMS in another 20 cities in New England and 3 cities in Canada.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Pet & Tie, Inc. must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

11. How can an investor cancel an investment commitment?

You may cancel an investment commitment for any reason until 48 hours prior to the deadline identified in the offering by logging in to your account with Netcapital, browsing to the Investments screen, and clicking to cancel your investment commitment. Netcapital will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment. If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be cancelled and the committed funds will be returned.

If we reach the target offering amount prior to the offering deadline, we may conduct the first of multiple closings of the offering early, if we provide notice about the new offering deadline at least five business days prior (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Thereafter, we may conduct additional closings until the offering deadline. We will issue Securities in connection with each closing. Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

Ownership and Capital Structure

The Offering

13. Describe the terms of the securities being offered.

We are issuing Securities at an offering price of \$0.28 per share.

14. Do the securities offered have voting rights?

The Securities are being issued with voting rights. However, so that the crowdfunding community has the opportunity to act together and cast a vote as a group when a voting matter arises, a custodian will cast your vote for you. Please refer to the custodian agreement that you sign before your purchase is complete.

15. Are there any limitations on any voting or other rights identified above?

You are giving your voting rights to the custodian, who will vote the Securities on behalf of all investors who purchased Securities on the Netcapital crowdfunding portal.

16. How may the terms of the securities being offered be modified?

We may choose to modify the terms of the securities before the offering is completed. However, if the terms are modified, and we deem it to be a material change, we need to contact you and you will be given the opportunity to reconfirm your investment. Your reconfirmation must be completed within five business days of receipt of the notice of a material change, and if you do not reconfirm, your investment will be canceled and your money will be returned to you.

Restrictions on Transfer of the Securities Offered

The securities being offered may not be transferred by any purchaser of such securities during the one-

year period beginning when the securities were issued, unless such securities are transferred:

- to the issuer;

There are no outstanding securities that are convertible into common stock. The issuance of additional securities will dilute the ownership of the crowdfunding investors. As a result, if we achieve profitable operations in the future, our net income per share will be reduced because of dilution, and the market price of our common stock, if there is a market price, could decline as a result of the additional issuances of securities. If we repurchase securities, so that the above risk is mitigated, we may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our common stock, if any, would decline. A sale of our company or of all the assets of our company may result in an entire loss of your investment. We cannot predict the market value of our company or our assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us. We anticipate that if we have any transactions with related parties, that they will be on an arms-length basis.

Financial Condition of the Issuer

27. Does the issuer have an operating history?

Yes.

28. Describe the financial condition of the issuer, including, to the extent material, liquidity, capital resources and historical results of operations.

The company has no burdening operating costs and is debt free. Expenses have been paid for by funds raised from angel investors, including any wages, legal fees, and software and development expenses. The company has raised \$195,000 from angel investors and expects future investment from angels and venture capital firms. Currently we have approximately \$10,000 of cash in the bank and we are seeking to raise money to meet the demand and launch our technology in two cities. In April 2018, we raised \$55,000 from an individual investor that allowed us to purchase Stellar Corporation's dog license software and acquire its customers. We sold the investor 550,000 shares of our commons stock at a price of \$0.10 per share. This purchase allowed us to assume the management and operation of the pet licensing systems of 39 municipalities. The annual software subscription fees paid by these 30 municipalities totaled \$42,525. We have contacted all the municipalities and we believe we can retain them as our customers, migrate them to our own technology and convert them to our own software service agreement. For the year ended December 31, 2017, we incurred total operating expenses of \$87,953, as compared to \$39,984 for the period from October 31, 2016 (inception) to December 31, 2016. The bulk of our expenses are for contractors (\$30,201 in 2017 and \$39,984 in 2016), marketing of \$31,410 in 2017 and software development of \$12,514 in 2017.
