### **Business and Anticipated Business Plan**

#### 6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

BNNano, Inc. is an advanced manufacturing company that pioneered the patent-pending NanoBarb, a unique and enhanced Boron Nitride Nanotube, that when added to commodities, improves their natural properties changing them into extraordinary materials. BNNano believes small things change the world and are working to transform commodity materials and bring manufacturing jobs back to the United States. At BNNano, we are leveraging innovations in cutting edge materials science to transform, revitalize, and revolutionize industrial commodities. We are an advanced manufacturing company that pioneered the patent pending NanoBarb<sup>TM</sup>, a unique and enhanced Boron Nitride Nanotube. When added to common materials, we believe that the NanoBarb<sup>™</sup> can improve their natural properties, changing them into extraordinary materials. BNNano is currently one of few companies in the world with a commercially viable manufacturing process for Boron Nitride Nanotubes. We believe our costs are orders of magnitude lower than most of our competitors, our quality is higher, and our IP portfolio protects our Boron Nitride NanoBarb<sup>™</sup>. NanoBarbs<sup>™</sup> is a unique and enhanced Boron Nitride Nanotube, that when added to certain commodities, we believe can improve their natural properties changing them into extraordinary materials. We believe that the transformational improvements of our products and technologies are adding value to commodity materials. But what could that mean? We believe it could mean that aluminum can become as strong as steel or titanium. ; We believe it could mean that copper can provide advanced thermal management solutions.; We believe it could mean that polyester could behave like Kevlar.; We believe it could mean that heat sinks could be made of plastic.; We believe our materials could provide new capabilities in water purification, fire prevention and enable hypersonic travel just to name a few.; We have focused on several market opportunities wherein the NanoBarbTM provides significant and meaningful value to our customers. BNNano's NanoBarbTM Powder is being applied in Additive Manufacturing. This industry is undergoing exponential growth given it's lower resource requirements, faster production cycle, and production flexibility. When our product is added, we believe it can augment performance with direct application and create revenue opportunities in 3D printing, automotive, aerospace, and numerous other industries. Our NanoBarbTM Enhanced Copper addresses a \$20 billion market opportunity. We believe our product can improve thermal management of electronic components allowing for increased reliability, increased premature failure, faster microprocessor operation, and higher performance. Our NanoBarbTM Enhanced Aluminum has immediate applications within the light-weighting industry. Benefits include decreased weight, improved performance, increased fuel efficiencies, and increased vehicle load while maintaining and often improving strength and energy absorption. The current light-weighting market is estimated to be \$200 billion.

#### 7. Material factors that make an investment in BNNano, Inc. speculative or risky:

- 1. Risks from Pandemics. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.
- 2. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
- 3. The failure to attract and retain key employees could hurt our business, and our management does not have extensive experience in the operation of businesses such as ours. Our success also depends upon our ability to attract and retain numerous highly qualified employees. Our failure to attract and retain skilled management and employees may prevent or delay us from pursuing certain opportunities. If we fail to successfully fill many management roles, fail to fully integrate new members of our management team, lose the services of key personnel, or fail to attract additional qualified personnel, it will be significantly more difficult for us to achieve our growth strategies and success.
- 4. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.
- 5. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. Before investing, you should carefully consider the specific risks and disclosures related to both this offering type and the Company.

- 6. Your shares are not easily transferable. You should not plan on being able to readily transfer and/or resell your security. Currently there is no market or liquidity for these shares and the Company does not have any plans to list these shares on an exchange or other secondary market. A "liquidation event" is when the Company either lists their shares on an exchange, is acquired, or goes bankrupt.
- 7. You may only receive limited disclosure. While the Company must disclose certain information, since the Company is at an early-stage they may only be able to provide limited information about its business plan and operations because it does not have fully developed operations or a long history. The Company may also only obligated to file information periodically regarding its business, including financial statements. A publicly listed company, in contrast, is required to file annual and quarterly reports and promptly disclose certain events through continuing disclosure that you can use to evaluate the status of your investment.
- 8. The Company may never receive a future equity financing or undergo a liquidity event such as a sale of the Company or an initial public offering, and you may not be able to sell any shares that you purchase in this offering. The Company may never receive a future equity financing, or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). If a liquidity event does not occur, such as a sale of the Company or an IPO, the purchasers could be left holding Company securities in perpetuity. The Company's securities have numerous transfer restrictions and will likely be highly illiquid, with potentially no secondary market on which to sell them. - 9. Future fundraising may affect the rights of investors. In order to expand, the Company is raising funds, and may raise additional funds in the future, either by offerings of securities or through borrowing from banks or other sources. The terms of future capital raising, such as loan agreements, may include covenants that give creditors greater rights over the financial resources of the Company.
- 10. Our ability to succeed depends on how successful we will be in our fundraising efforts. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
- 11. Our auditors' report includes a going concern paragraph. Our financial statements include a goingconcern qualification from our auditors, which expresses substantial doubt about our ability to continue as a going concern. We have operated at a loss since inception. Our ability to operate profitably is dependent upon, among other things, obtaining additional financing for our operations. These factors, among others, raise substantial doubt about our ability to continue as a going concern. The accompanying financial statements do not include any adjustments that take into consideration the uncertainty of our ability to continue operations.
- 12. The Company has the right to extend the Offering deadline. The Company may extend the Offering deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the maximum offering amount even after the Offering deadline stated herein is reached. Your investment will not be accruing interest during this time and will simply be held until such time that Offering is closed, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you.
- 13. No governmental agency has reviewed the Company's offering and no state or federal agency has passed upon either the adequacy of the disclosure contained herein or the fairness of the terms of this offering.
- 14. Fundraising outside of the platform. Our ability to succeed depends on how successful we will be in our fundraising effort. We plan to diversify fund-raising beyond this campaign, in order to use resources to build the necessary business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.

- 15. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 16. Our future growth depends on our ability to develop and retain customers. Our future growth depends to a large extent on our ability to effectively anticipate and adapt to customer requirements and offer services that meet customer demands. If we are unable to attract customers and/or retain customers, our business, results of operations and financial condition may be materially adversely affected.
- 17. The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

You should not rely on the fact that our Form C, and if applicable Form D is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering.

18. Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. 19. The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. 20. The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

21. The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. BNNano, Inc. ("the Company") is a corporation organized under the laws of North Carolina. The Company operates as a manufacturer of nanomaterials. Its primary product, NanoBarb<sup>™</sup> aims to provide solutions for problems across many structural applications. The Company pioneered the patent pending NanoBarb, a unique and enhanced Boron Nitride Nanotube, that when added to commodities, improves their natural properties changing them into extraordinary materials. Under the Company's articles of incorporation, the Company is authorized to issue 100,000,000 common shares and 20,000,000 preferred shares. Since inception the Company has financed a large portion of its operations through issuances of SAFE

agreements, as of the date of filing of this offering the outstanding balance on those SAFE agreements is \$1,465,000. The SAFE agreements have no maturity date and bear no interest. The SAFE agreements provide the right to the holder to future equity in the Company in the form of SAFE Preferred Stock. With a valuation cap of \$5,000,000. Upon conversion, the SAFEs can convert with a discount rate of 80%. The Company also has 5,828,396 shares reserved for issuance under its Stock Option Plan. The Company values each share option at \$0.38 per share. In 2022 the Company was able to raise \$187,700 via sale of its common stock under Regulation D exemption. As of the date of filing of this offering the Company had 12,674,156 shares of common stock issued and outstanding. During the first eight months of 2022 the Company was also able to generate approximately \$200,000 in sales, which represents an increase of approximately 78% when compared to the previous full fiscal year. In the year ended December 31, 2021, sales amounted to \$112,114, while the cost of goods sold was \$34,968, resulting in a gross profit of \$77,146. For the same year, the total operating expenses were \$1,020,606 which after taxes and interest expenses resulted in a net loss of \$956,926. During the same year, the Company was able to raise \$1,069,655 via the sale of common stock through a Reg CF offering conducted on Netcapital. The Company also raised \$264,007 via the sale of common stock under Regulation D exemption. In the same year, the Company paid back \$44,868 that was outstanding via a Note Payable. The cash balance at the end of the fiscal year stood at \$417,308. In the year ended December 31, 2020, sales amounted to \$64,551, while the cost of goods sold was \$79,279, resulting in a gross loss of \$14,728. For the same year, the total operating expenses were \$905,117 which after debt forgiveness, tax and interest expenses resulted in a net loss of \$868,013. During the same year, the Company was able to raise \$552,648 via the sale of common stock under Regulation D exemption. The Company also issued \$195,000 in SAFE notes and \$42,706 in Notes Payable. The cash balance at the end of the fiscal year stood at \$82,794. With the net proceeds from this raise the Company plans to invest in payroll and new hires, facilities improvement, capital equipment, product development, sales and marketing, intellectual property and further research and development.

Working with our customers and our strategic partners, we've shipped more than a quadrillion NanoBarbs since the last raise on Netcapital and BNNano was working with some world class customers and strategic partners: like the Navy, organizations like NASA and they're working to develop products and materials to protect astronauts in spacecraft. True Velocity out of Garland, Texas, who are working with enhanced polymers and plastics. We're working with Eck Industries out of Wisconsin to help develop and improve our aluminum and our metallurgy. We're working

with, uh, international companies as well, like Huneed out of Korea to help advance additive manufacturing in aerospace. We are fortunate that we have a world class group of customers and also have a lot of strategic relationships that we are looking to grow as we move forward. But how do these NanoBarbs work? Well, if you were to take rock candy and shrink it down to the nanoscale, this is a lot like what our NanoBarb looks like. It consists of a Nanotube, which is a lot like a straw. But only one or two atoms thick and super strong and super stiff. So why do we add these nano-crystals to the outside of the Nanotube? A lot like rebar and concrete, provides enough strengthening to enable skyscrapers to be built on the foundations. Our NanoBarb has this irregular surface, just like rebar, enables a significant strengthening in a lot of materials like aluminum and polymer and ceramics, which enable them to be significantly strengthened for new applications and a lot lighter materials for use in things like spaceships, cars, trains, personal protection and so on. Our NanoBarb comes in the form of a powder. And for example, right here is the most Boron Nitride Nanotubes that has ever been produced and held in one location. And we are getting ready to ship this to a customer, but we take this powder and we can add it to materials like aluminum and polymers to create filaments for additive manufacturing, higher strength aluminum for lighter weight structures and stronger structures. So when printing with our NanoBarb filament, not only is the filament super strong, but our NanoBarbs act like a screw between two pieces of wood in between the layers of filament, significantly enhancing that interlayer strength. The markets that we are striving for are raw materials. Which on its own is estimated to be a 10 billion marketplace by the year 2027. The other area where we have a great deal of interest is in lightweighting. And that is to make things lighter and stronger, which includes metals, it includes plastics, ceramics. That market is estimated to be almost 270 billion by the year 2027. And part of what we're doing now is we want to come back to the crowd to raise more funds so that we can engage with these customers so that we can continue to develop our product. And so that we can grow our company even more. The crowd gave us introductions to companies that have become our customers. They gave us introductions to people that have helped us understand our technology better and to help expand our business development opportunities. That's our roots. And we want to come back to you, to ask you again to join us as we grow our company, but we want to ask you for more than just an investment. What ideas do you have that we can consider? So we'd like to invite you to join the BNNano family, to invest in us, to help us grow the company, to help us develop new products that can really help humanity evolve into the next era of materials, to enable those ambitions for the 21st century.
