### Medication Adherence

Healthcare providers, pharmacists and pharmaceutical companies all know that medication adherence can be the single biggest impact on health outcomes, but that only 40-50% of patients routinely keep to prescribed regimens. This leads to immeasurable human costs, hundreds of billions in avoidable healthcare expenses and equal distress to the bottom line of pharmaceutical companies-money that could be used to develop new and innovative treatments and cures.

Pharmaceutical companies could make an additional \$400 billion per year by maximizing medication adherence, and RAIDAtech Patient AIO (All-in-One) solution can help them do it. A 1% market share would generate \$4 billion in revenue.

### Customer Engagement

Customer Engagement is expected to become the single largest component of the marketing mix in the coming years. Half of all companies reported plans to increase spending on customer engagement, currently around \$1.3 trillion. One in six marketing dollars is spent on innovation, representing a potential market of at least \$200 billion.

RAIDatech's AIO (All-in-One) Engagement tools allow brands to engage in a sustainable, affordable and secure manner that no other solutions company can match. A 1% market share of a \$200 billion (and growing) sector would be at least \$2 billion.

## Anti-Counterfeiting

Counterfeiting costs brand owners at least \$1.5 TRILLION annually. RAIDatech provides the most effective and affordable solutions to stopping counterfeiters.

Consumers lose, too. Thousands have died or been sickened by counterfeit food and beverages. Trade in illegal goods costs 4 million legitimate jobs globally. RAIDatech solutions allow consumers identify fake products.

At least \$150 billion in tax collection each year worldwide ends up in the hands of criminals instead of being used for schools, hospitals or other worthwhile projects. RAIDatech helps agencies keep counterfeits off the streets and tax dollars flowing where they are most needed.

We have cultivated potential business with major companies interested in RAIDatech anti-counterfeiting solutions. These include companies in the consumer packaging industry, wine/spirit bottle closures, collectibles, and other sectors impacted by counterfeiting.

We are optimistic about closing deals with one of these prospective partners that could generate tens of thousands of dollars each month as a reliable stream of sustained revenue. Anti-counterfeiting solutions globally are a \$150 billion per year industry—if RAIDatech could realize a market share of just 1%, it would mean \$1.5 billion in revenues. This is a crowded market with many competitors, but all rely on technology that is vulnerable to hacks and none can deliver a solution that can absolutely not be profitably counterfeited.

## Secure Data Transmission

We read or hear every day about Fortune 500 companies and governments being hacked or compromised. RAIDatech provides the only 100% secure data transmission protocol. It simply cannot be hacked, intercepted, compromised or manipulated, even by quantum computers.

The global secure file transfer market will grow to a \$1.6 billion market in the next five years, and only 10% of enterprises have adequate protection. There is significantly less competition in this sector and, again, none can provide 100% secure, quantum-safe solutions, let alone provide any solution as affordably as RAIDatech. This industry provides significant opportunity to gain market share and brand awareness.

We have generated considerable interest in RAIDA DATA, a protocol for the secure transfer of data in real-time. Possible interested parties include well-known companies in oil and gas, technology and healthcare, where government regulations require the kind of solution only RAIDatech can deliver.

Global spending on information security will top \$125 billion in 2019. A 1% market share would equate to over \$1.2 billion in revenues.

Virtually every industry needs to protect private, proprietary or privileged communications. Current encryption technology is ineffective, inefficient and costly. RAIDAtech solutions solve these problems with unique, patented protection while also creating new and innovative ways companies can engage with their clients/customers, employees or other stakeholders.

The market potential for secure communications is estimated to grow to over \$60 billion by 2025, without the added benefit of customer engagement/immersion. A 1% share of that market would translate to \$600 million in revenues.

## Asset Tokenization

Business owners need access to capital to grow their business, yet conventional approaches are time-consuming, costly and complicated. Investors want greater investment opportunities, expanded liquidity and transparent processes. The RAIDAQ Security Tokenization Platform offers fully compliant asset tokenization that's fast, safe and affordable.

The RAIDAQ Tokenization Platform has dozens of prospective clients currently considering using our solutions to tokenize their assets. This is a very immature but potentially revolutionary market sector. Digital asset solutions can speed transactions (and no technology can come anywhere close to approaching RAIDAtech's potential of 8 million transactions per second) while eliminating the cost and friction of countless middlemen and escrows services.

Digital asset tokenization gives investors greater control and more diverse liquidity opportunities. The revenue opportunities are difficult to project, but there are over 6 million private companies in the United States alone that could seek to tokenize their ownership units rather than use traditional (and most costly) public offerings. The average IPO costs \$1.5 million to underwrite. RAIDAQ can offer digital tokenization at a fraction of that cost. The Federal Reserve Board estimates the value of non-public US companies at \$5.3 trillion. Tokenization also has applications for real estate (globally worth \$200 trillion) and just about any form of asset. Were RAIDAQ tokenization to attract just 1% of private companies (60,000 clients), tokenization of those assets alone could generate \$600 million.

## Quantum Safety

The advent of quantum computing is coming sooner than most expected. These advances were considered decades away just a few short years ago--there are limited-function quantum computers today and their capabilities will only improve. RAIDAtech is the only quantum-safe technology for authentication and data security.

Continuous advances in quantum computing, threaten to completely nullify the centerpiece of distributed ledger (blockchain) technology: asymmetric elliptic curve cryptography. The Quantum Era is near, if not already upon us, as many experts believe. Quantum computers rely on quantum mechanical phenomena like entanglement and superposition to operate on quantum bits of data (qubits). Traditional bits are binary: they are either ones or they are zeros. Qubits, essentially, can be ones, zeros or both at the same time. A quantum computer is able to process data millions of times faster than a traditional one.

We are, then, already in a post-blockchain environment. The next generation of technology to protect privacy, financial security and intellectual property will be effective only if it is quantum-safe and provides solutions to blockchain's problems with scalability, efficiency, governance and ecological harm.

adversely affected and we may be unable to execute our business plan, and our business could fail. Investors could therefore be at risk of losing their investment.

## Products and Services

Will there be sufficient market for our products and at what price point? We will only succeed if there is sufficient demand for products and services.

## Competition

We compete with other companies. A number of competitors exist that either provide authentication, anti-counterfeiting, cybersecurity or related products and services. None, however, has a comparable security backbone to the patented RAID technology. Competitors and other companies may directly compete with us.

Many of our competitors have greater brand recognition and greater financial, marketing and other resources. This may place us at a disadvantage in responding to our competitors' pricing strategies, technological advances, advertising campaigns, strategic alliances and other initiatives. Consequently, such competitors may be in a better position than the Company to take advantage of customer acquisition and business opportunities, and devote greater resources to marketing and sale of their product offerings. There cannot be any certainty that the Company will be able to compete successfully. If the Company cannot break through and compete successfully, investors may be at risk of losing their investment.

## Management/Team

We depend on a small management team and depend on their skill and experience. Each has a different skill set. Our ability to raise sufficient capital may have an impact on our ability to attract and hire the right talent. Our success is dependent on our key personnel. We believe that our success will depend on the continued employment of our senior management and key personnel. If one or more members of our senior management were unable or unwilling to continue in their present positions, our business and operations could be disrupted and this could put the overall business at risk, and therefore investors could be at risk of losing their investments.

We are controlled by our officers and directors. Our officers and directors currently hold the majority voting units, and at the conclusion of this offering will continue to hold a majority of the company's units. Investors in this offering will not have the ability to control a vote the board of directors.

We may not effectively manage growth. The anticipated growth of the Company's business will result in a corresponding growth in the demands on the Company's management and its operating infrastructure and internal controls. While we are planning for managed growth, any future growth may strain resources and operational, financial, human and management information systems, which may not be adequate to support the Company's operations and will require the Company to develop further management systems and procedures. our business. If this business cannot effectively hire employees to help the company grow, the business could be at risk overall of not succeeding, and investors therefore may be at risk of losing their investment.

Management has broad discretion as to the use of proceeds. securities, a rights offering, and other strategic alternatives. Such additional financing may not be available to the Company, or, if available, the Company may be unable to undertake such additional financing on terms that are advantageous to the Company. It is not possible to predict the adoption rate of the end customer due to the risk that our products will not be commercially or technologically adopted.

We must continue to enhance the features and functionality of our technology and product offerings. The effective performance, reliability and availability of our technology and product offerings are critical to our reputation and our ability to attract and retain users and customers. If we do not continue to make investments in product development and, as a result, or due to other reasons, fail to attract new and retain existing customers and investors, this could significantly decrease the value of our products and services to all customers and stakeholders. ## General economic and market conditions

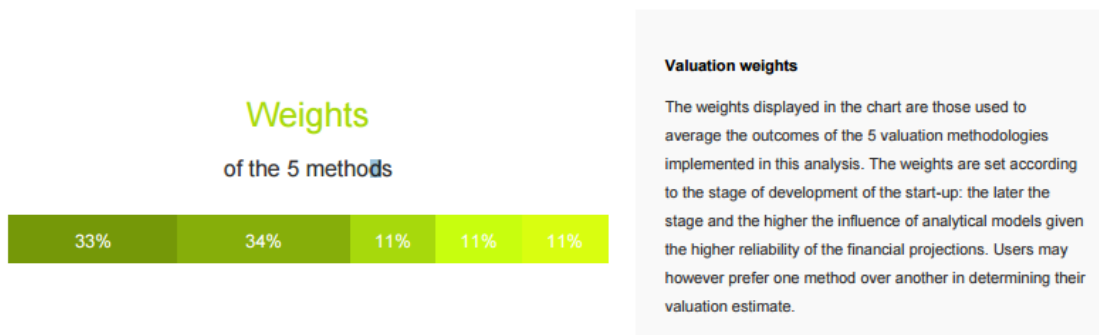

## 1. Business and Summary of Significant Accounting Policies

### Description of Business and Basis of Presentation

RAIDAQ, LLC, (the Company) is a development stage Wyoming corporation. RAIDAQ LLC dba RAIDAtch is a research, technology and Solutions with Services (SwS) company with exclusive license to develop applications for the provisionally-patented RAIDA technology, a quantum-safe, self-healing, simple, fast and reliable global system for counterfeit detection and authentication.

## 2. Other Assets

The Company has invested \$20,000 into gold with United Precious Metals Association (UPMA), where UPMA vaults the gold for a monthly fee. The unrealized gain on these securities is recorded in equity section.

## 3. Income Taxes
