Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. - 3. our results of operations, financial position and capital resources;
- 4. current business conditions and projections;

- 6. the hiring of key personnel and the experience of our management;

- 8. the risk inherent in the development and expansion of our products;
- 9. our stage of development and material risks related to our business:
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- 11. industry trends and competitive environment;
- 12. trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the investor. - Signed \$4.6 m in new contracts since 1/1/2021; founder's last company gave investors 17x in 3 yrs!
- From Google Earth inventors, game-changing AI tech that helps cities cut costs + GHGs by 30-100%
- 1 of only 100 companies in the world selected to be a World Economic Forum Global Innovator 2021-23

Historical Results of Operations

- Revenues & Gross Margin. For the period ended December 31, 2020, the Company had revenues of \$5,000 compared to the year ended December 31, 2019, when the Company had revenues of \$152,018.
- Assets. As of December 31, 2020, the Company had total assets of \$1,038,801, including \$86,144 in cash. As of December 31, 2019, the Company had \$782,094 in total assets, including \$483,321 in cash.
- Net Loss. The Company has had net losses of \$1,585,772 and \$1,292,065 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Cityzenith cash in hand is \$1,000,000, as of May 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$150,000/month, and operational expenses have averaged \$200,000/month, for an average burn rate of \$350,000 per month. Our intent is to be profitable in 12 months.

There have been no material changes since the date of our financials. We have been maintaining a consistent burn rate, and have begun to see revenues from customer contracts signed this year. We hope that will bank more than \$1 million this year based on \$4.6 million in new signed commercial agreements.

We hope to maintain a similar burn rate, but increase revenues to \$150,000 per month over the next six months. We are expecting a large advance on a major project which was recently signed.

These projections cannot be guaranteed.

We have multiple sources of additional capital. We have over 5000 shareholders who have never let us down. We are currently running a regulation A+ capital raise and have already raised \$3 million since December 2020.


