- We cannot control if a similar movie is released. A feature narrative or documentary about Bible Smuggling would be in direct competition with our film if released within 90 days of each other.
- We can control who we cast in the film and understand their public perception before filming takes place but once the film is complete their public perception could change in a way that could damage the film's perception.
- Distribution is something we intend to do ourselves but if we do invite a distributor onto the team we will give away certain control of the film and distributors can be a risk for filmmakers if the film is not handled in a way that is agreed upon.
- We cannot control other films released on the same date. There is a risk of going up against a much larger film from a much larger distributor with a much larger marketing budget than we have.
- There is a risk when selling tickets to a theatrical release of a movie. The trailer is intended to drive sales but sales are totally dependent on people purchasing that is out side of our control
- There is a risk when selling Video On Demand. We intend to market and persuade people to purchase, but their decision to purchase is entirely up to them and impossible to predict.
- Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.
- Nathan VonMinden is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.
- Keith Rushing is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use

the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

50% Cast and crew salaries

27.5% Traveling and lodging costs for cast and crew

15% Post-production costs (music, editing, legal)

7.5% Wefunder intermediary fee

If we raise: **\$1,070,000**

Use of Proceeds:

60% Cast and crew salaries--hiring additional extras, more time shooting, better props, and more reputable actors.

12.5% Traveling and lodging costs for cast and crew

20% Post-production costs (music, editing, legal, visual effects), including an orchestra of ~double the size (compared to our minimum goal), twice as many tracks, and the licensing rights to the music used.

7.5% Wefunder intermediary fee

If we reach our target offering amount prior to the deadline, we may conduct an initial closing of the offering early if we provide notice about the new offering deadline at least five business days prior to the

Investors in this Offering will receive a recoupment of their investment plus a percentage of the Gross Producer Revenues:

"Recoupment" means the point where Financing Group has received **compensation equal to the amount of the Budget plus 30% for "Early Bird Financiers" and 20% for non early bird financiers.**

"Early Bird Financiers" are financiers who fund the first \$75,000 of the production budget.

"Gross Producer Revenues" means all revenue receivable by the Production Company from the Film's Distributor including theatrical, home video exhibition, electronic distribution (including download to own, electronic sell-through, streaming, or any other form of "digital rights" as that term is commonly understood

in the entertainment industry), television broadcast/exhibition (including free, VOD, pay-per-view, pay, cable and the like), and mobile broadcast/exhibition and distribution with respect to the Film and trailers thereof, and excerpts and clips therefrom, in any and all languages and versions, including dubbed, subtitled and narrated versions. **Gross Producer Revenues are divided into Financing Group Share (being 40% of Gross Producer Revenues after Recoupment)** and Production Company Share (being 35% of Gross Producer Revenues after Recoupment) and Charitable donations (being 25% of Gross Producer Revenues after Recoupment).

Investors in this Offering will not be receiving voting rights.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor’s rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company’s operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

Additional risks related to the rights of other security holders are discussed below, in Question 20.

19. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?

There are no units issued in this offering. This is a Funding Agreement. For more information please review the Offering Details Document.

As a holder of a Funding Agreement you will have no voting rights, and limited ability, if at all, to influence out policies or any other corporate matter, including the election of directors, changes to the Company's governance documents, additional issuances of securities, company repurchases of securities, a sale of the Company or of assets of the Company, or transactions with related parties.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the operating agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

**The unitholders** have the right to redeem their securities at any time. **Unitholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional securities, an Investor's interest will typically also be diluted.

Based on the risks described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common units that take into account factors such as the following:

- unrelated third party valuations of our common units;
- the price at which we sell other securities, such as convertible debt or preferred units, in light of the rights, preferences and privileges of our those securities relative to those of our common units;
- our results of operations, financial position and capital resources;
- current business conditions and projections;
- the lack of marketability of our common units;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;

- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

Our vision is to create 3 movies and bring them to market starting with Bible Smugglers. Our other 2 films are a Christmas stop motion action family comedy film called STEAL THE NAUGHTY LIST and a movie based on the NYT best-selling book MURDER BY FAMILY by Kent Whitaker. NOTE: these other films will be different entities (Investors in this Offering will NOT be entitled to revenues generated from the other two films). We want to create a robust repeatable system for bringing these kinds of film to market and raising the funds from the profits of one film to create the next.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.
