BUSINESS AND ANTICIPATED BUSINESS PLAN

7. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

The Issuer is a California licensed Limited-Service Restaurant (NAICS 722513), specifically, an independent taproom and bottle shop located in the Laurel District of Oakland, California. Dedicated to being a "third space" community gathering place, the Issuer offers its' neighborhood a destination to bring people together over specialty brewer-focused craft beer and a casual dining experience highlighting the fresh ingredients of

Oaxaca Mexico. The Issuer has been in operations for 2.5 years and intends to expand its physical and digital presence by building out the outdoor space of their existing location to attract more customers and to grow their community, and creating and distributing digital content for marketing to deepen and broaden the Degrees Plato brand.

THE OFFERING

USE OF FUNDS

1. What is the purpose of this offering?

The Issuer intends to use the proceeds of this offering to develop outdoor space to attract more customers and to grow their community, refinance their existing SBA loan, create and distribute digital content for marketing to deepen and broaden the Degrees Plato brand, and have working capital to maximize operational efficiency and foster sustainable growth.

2. How does the issuer intend to use the proceeds of this offering?

72% will be used to refinance their existing SBA loan, 24% will be used to develop outdoor space of their existing location, and 4% will be used for marketing and cash reserves.

DELIVERY & CANCELLATIONS

3. How will the issuer complete the transaction and deliver securities to the investors?

The following describes the method and the process to invest in the Issuer/Company's debt securities, including how the Issuer/Company will complete an investor's transaction(s) and deliver securities to the investor.

- 1) Auction Process – The offering will use the Auction method to arrive at a price for the bond security's final clearing yield (interest rate at which the bond is repaid at). During an auction, potential investors bid within a pre-set range of yields. A successful auction arrives at a single offering yield, which is the yield at which the last available unit of securities in the offering is sold. SMBX's auction method is known as a 'modified-dutch auction' (MDA), which is a type of 'uniform price offering' (UPO). The ultimate goal of an MDA on the SMBX is to arrive at a uniform yield or what we called a final clearing yield for the bonds.
- 2) Investor Commitment – The Investor will place bid order(s) through the SMBX mobile app, the SMBX Investment Center web client, or the SMBX Investment Center mobile web client by inputting the total amount they would like to invest at a preset value of \$10 per bond and a preferred yield within the preset yield range that they would like to receive for the repayment of the bond. In an auction process however, the investor should be mindful that there will be other investors that may bid at a lower yield than their own bid(s), so their bid(s) may potentially be outbid in the event there are more investors than available bonds. Once the bid order(s) are placed, the investor will then receive order confirmation(s) via email with their bid order details. An investor has up to 48 hours before the close of an offering's auction to cancel their bid order(s).
- 3) Investor Transfer of Funds – The initiation for a Transfer of Funds will happen simultaneously when an order is placed. The bid order(s) will sit in the investor's portfolio as pending until the transfer of funds is

complete. The funds will sit in an escrow account on behalf of the issuer until the close of a successful offering.

- 4) Progress of the Offering – The Investor will receive periodic email updates on the progress of the offering including how much has been raised so far and how many days till the end of the offering.
- 5) Closing of an Offering: Original Date – At the close of the offering, investors with ‘winning bids’ will receive an email notifying that they have been allocated a number of bonds and that the final clearing yield has been defined as a specific interest rate. The final clearing yield may potentially be a higher yield than what an investor has place a bid on, however, it will never be lower than the yield they requested. The investor will also be asked to reconfirm their bid orders within 5 business days by clicking on a link included in the email. Orders not reconfirmed within 5 business days will be cancelled and refunded to investors’ bank accounts or credit cards. For investors that did not get allocated any bonds, they will receive an email notifying them that their bid orders have been outbid and that they will receive a refund to their bank accounts or credit cards.
- 6) Early Closing – In the event an offering has met its 21 day minimum open requirements and has been fully subscribed before the offering’s original close date, the Issuer/Company may choose to settle the auction and close the offering early. The offering’s auction will then be settled on the issuer’s/company’s direction by the SMBX and the final clearing yield will be determined at that moment in time. An email notification will be sent to all investors (both with winning bids and those who have been outbid) and those with winning bids will proceed with the reconfirmation process as per above in #5. All investors who have been outbid will receive notification that they have been outbid and that funds will be refunded to their bank accounts or credit cards. The decision for an early closing and the email notifications will be sent at least 5 business days prior to the original close date.
- 7) Securities Transfer(s): Bond Certificates – After an offering is confirmed to be fully subscribed and all investors with ‘winning bids’ have reconfirmed their bid orders, the Issuer/Company will direct SMBX to issue on their behalf, the electronically signed bond certificates in pdf format to investors via email. The bond certificates will be the investors’ authoritative copy of ownership of the bonds. All bond certificates have unique identification codes that the Issuer/Company and the SMBX have records of. If you misplace or lose your bond certificate(s), please contact support@thesmbx.com and notify them that you need a replacement certificate. SMBX and the Issuer/Company will then update and void your old certificate(s) on our records and issue you new certificate(s) via email.
- 8) Portfolio Entry – On the same day investors receive their bond certificate(s) via email, they will see the bonds registered in their portfolio under Bonds. That bond issuance date will also be the first day their bond securities will start accruing interest for the month. Investors will then start receiving principal + interest (earnings) on their bond securities exactly 1 month on the same day of the bond issuance date (except if the day lands on a holiday or weekend or on a day that a particular month may not have the same day i.e. the 31st, then repayments will be recorded and credited the following business day).

4. How can an investor cancel an investment commitment?

Overview

Degrees Plato is a taproom and bottle shop serving the Oakland community that offers close to 50 taps of predominantly California craft brews. Founded by husband & wife team Rich Allen & Mercedes Sperling in 2016, Rich, along with Mercedes, curates and brews at a Cicerone level having spent over a decade working in the beer industry and observing how breweries have become the modern pubs of the world, welcoming families and communities as place to connect.

Over the last 2-year period, from 2017 through 2019, Degrees Plato has experienced 7% year over year growth, with minimal marketing. Degrees Plato has also increased its gross profit margin from 16% in 2018 to 20% in 2019, which is considered very healthy in its specific industry.

Degrees Plato intends to continue to grow its sales and to become a destination for its Oakland neighborhood, the Laurel District. To do so, Degrees Plato will develop outdoor space in time for the spring season, thus equipping its venue with a unique offering for its location and will begin to create and distribute marketing content to build its brand awareness. Further, Degrees Plato will conduct a Regulation Crowdfunding offering on the

SMBX platform to refinance its existing SBA loan, so as to engage with its community by rewarding it with the financing profits that would otherwise go to the bank.

Milestones

Degrees Plato was incorporated as California state Limited Liability Company in 2016, doors opened for business in June 2017.

Historical Results of Operations

- Revenues & Gross Margin. For the period ended December 31, 2018, the Company had revenues of \$1,035,654 compared to the year ended December 31, 2017, when the Company had revenues of \$432,977 (please note operations began in June 2017 which accounts to why gross profit was distorted due to the initial high costs of goods sold relative to sales). Furthermore, the Company's annualized 2019 revenues are \$1,105,559 (yearend 2019 financials have yet to be finalized as of the offering start date). Our gross margin was -2.8% in fiscal year 2017, 16% in fiscal year 2018, and 20% in fiscal year 2019.
- Assets. As of December 31, 2018, the Company had total assets of \$162,485 while as of December 31, 2017, the Company had total assets of \$136,023. The Company's 2019 total assets are \$204,751 as of October 31, 2019 including \$8,626 in cash and \$74,668 in credit card receivables.
- Net Gain/Loss. The Company has had net gains of \$16,527 and net losses of \$249,814 for the fiscal years ended December 31, 2018 and December 31, 2017, respectively. Annualized net gains for 2019 stand at \$80,411.
- Liabilities. The Company's liabilities totaled \$220,483 for the fiscal year ended December 31, 2018 and \$247,243 for the fiscal year ended December 31, 2017. The Company's 2019 liabilities are \$171,961 as of October 31, 2019.

The Company's ability to be a going concern is not dependent on reaching our minimum funding target. We have a history of bootstrapping our operations and will be able to scale back as necessary to continue operations regardless of capital raised. If our offering is not successful, our decision to proceed with the development of outdoor space and increased marketing will be dependent on our cash flow generated from sales. In the event our offering is successful and we reach our minimum funding target, we will deploy approximately 72% to refinance our existing SBA loan, 24% to build out the outdoor space and 4% to enhance our marketing strategy and to have some cash reserves.

Liquidity & Capital Resources

The Company has assets in the form of leasehold improvements and equipment, valued at \$120,000+. While it cannot be stated with certainty, it is assessed that the cash conversion period of these assets is 180-365 days.

Runway & Short / Mid Term Expenses

Degrees Plato cash on hand is \$8,626 and credit card receivables is \$74,668 as of October 31, 2019, therefore \$83,295 of Degrees Plato assets are at present liquid. Over the last fiscal year, the period of January through October 2019, revenues have averaged \$92,000+/month, cost of goods sold has averaged \$75,000/month, and operational expenses have averaged \$11,100/month, for an average burn rate of \$85,400/month. There are no material or extraordinary trends in our financial operating history.

Our intent is to grow our taproom sales by 15% through the deployment of a new outdoor space, which will draw in more foot traffic, and to increase our marketing efforts so as to establish brand recognition around Degrees Plato, which we expect, will increase our bottle shop sales by 20%. This amounts to expected average monthly sales and services revenue of \$125,000, cost of goods sold of \$90,000, with no additional increase in operational costs.
