Founded by husband and wife Manuel and Geiszel Godoy, BSE is known for popular graphic novels based on African history across the diaspora, including "Black Sands," "the Seven Kingdoms," and developing animated shorts.

As part of the agreement, Hartbeat will offer strategic advisory services to help push Black Sands' storytelling efforts into the TV and film realm. Currently, the two companies are collaborating on an animated feature and series focusing on the Black Sands eponymous flagship series.
