# #5. Our early numbers are AWESOME (and growing!)

In 2020, our initial market (SAT-prep) evaporated when colleges stopped requiring SAT scores due to COVID-19. But we are a nimble and hard working team, who won't be held back! We pivoted quickly and produced some incredible outcomes for the business over the past year. This includes:


- 91% of \$1 trials now convert to paid monthly or yearly subscription.
- Monthly Recurring Revenue increased each month in 2020 (despite the SAT market evaporating).
- Course creation was sped up by 500% through creating a Learning Management System (LMS) that anyone can use to create an Everydae-style course (and which is the backbone of adaptivity).
- We cracked user engagement and lifted our DAU:MAU ratio from 18% -36%. This is seriously awesome - for context, DAU:MAU measures how engaging/sticky your product is and 20% is the benchmark for something good.
- We accelerated our roadmap by years to produce 6 additional Math, Science and English courses in Q4 2020!
- We brokered a lucrative white-label partnership with a job-ready skills provider that sells to institutions and can expect a healthy rev-share in 2021.
