We may not be able to sign-on enough schools: However, our sales pipeline is 100+ schools (potential of 100,000 students, \$2,000,000 sales, \$250,000 ARR, \$20,833 MRR). We've already signed-on 3 schools (5000 students, \$100,000 in sales, \$12,500 ARR, \$1,042 MRR), so we're 5% of the way there.

A student may post an inappropriate video: Should that happen, each video has a button that enables any viewer to "flag" the video for take-down. Further, because each student's channel is uniquely registered to them, administration can take rehabilitative or disciplinary action as the case may be. We will also insert software to scan videos for inappropriate material.

A school may not be able to afford to pay for all of its support and maintenance fees: Where possible, we are willing to work with schools on campaigns to raise the funds they need to ensure 100% student participation.

Our platforms may experience downtime: Our platform partner, PublicVine, uses AWS for its server infrastructure (as do so many leading platform brands). So, chances are that downtime will not be isolated to Video Yearbook and we believe that partner schools and students will understand this.

The technology environment might change and expose our Company to technology pressures we may not have foreseen.

The competitive environment might change and expose our Company to competitive pressures we may not have foreseen. The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

(ii) if the valuation for the company is more than \$1 million (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of (a) the Valuation Cap divided by (b) the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap.

For purposes of option (ii) above, the Company's capitalization will be measured as all shares of stock outstanding at the time, not including any SAFEs or convertible notes, plus any common stock reserved and available for future grant under any equity incentive or similar plan of the Company or to be created or increased in connection with our equity offering at that time

Investors who receive shares subject to the Valuation Cap will receive a per share liquidation preference and conversion price designed to provide protection against the price of the Preferred Stock

being diluted to a value below the price per share at the time they receive **Preferred Stock**.

This dilution would

mainly occur due to the issuance of additional stock by the Company.

Investors who receive **Preferred Stock** subject to the Valuation Cap will also receive dividend rights.

No Voting Rights.

Investors will have no voting rights.

Instead

the Company's CEO will be provided a proxy to vote on the Investor's behalf.

Private Sales for Major Investors. Investors who invest at least \$25,000 and are "accredited investors" will receive the right to purchase a pro-rata share of privately placed securities occurring after an equity offering covered by the SAFEs.

Major Investor Threshold

Definition: A major investor is one who invests a minimum of \$25,000.00 and are "accredited investors" as defined by Rule 501 of Regulation D (17 C.F.R. §230.501(a)).

Execution. Investors who invest less than \$25,000.00 will typically not execute transaction documents in order to receive Units at the time of an applicable equity offering. Termination of the Company.

If the Company ceases operations, liquidates, dissolves, winds up or has its assets assigned to creditors prior to an issuance of securities involving **Preferred Stock**, the Company will pay first the other holders of existing **Preferred Stock**, based on the terms of the Company's certificate of incorporation, and then holders of the SAFEs. These payments will occur before any distributions to holders of common stock.

If there are not sufficient Company assets to pay holders of the SAFEs the amount of their investments, as determined by the Company's board of directors, payments will be made on a pro-rata basis. In this case, Investors may not recoup part or all of their investment from the Company.

Repurchases

The Company has yet to authorize Preferred Stock, which Investors in this Offering would receive if the SAFE converts. Preferred Stock has liquidation preferences over Common Stock; however, Investors in this Offering would not be receiving voting rights.

Because the Investor holds no voting rights, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Video Yearbook, Inc. was incorporated in the State of Delaware in August 2019.

Since then, we have:

- Patented solution to \$1 billion problem (patent owned by Co-Founder, Nam Mokwunye)
- Minimized technology risk by licensing
- 20+ yrs. experience per team member
- Sales pipeline of 100+ schools
- 100% of sales team are investors

Historical Results of Operations

Our company was organized in August 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- Revenues & Gross Margin. For the period ended November 30, 2019, the Company had revenues of \$182
- Assets. As of November 30, 2019, the Company had total assets of \$24,073, including \$6,227 in cash.
- $\it Net Loss.$ The Company has had net losses of \$56,374 as of November 30, 2019.
- Liabilities. The Company's liabilities totaled \$29,368 as of November 30, 2019.

Liquidity & Capital Resources

To-date, the company has been financed with \$50,000 in Common Stock.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 5 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Video Yearbook, Inc. cash in hand is \$6,227, as of January 2020. Over the last three months, revenues have averaged \$60/month, cost of goods sold has averaged \$177/month, and operational expenses have averaged \$18,791/month, for an average burn rate of \$18,908 per month. Our intent is to be profitable in 24 months.

If necessary, we can call upon additional capital from the founding team to cover short-term operations. We also have over \$17,000 in accounts receivables that we

hope to start collecting in the next month.

We currently have 3 schools signed up with 8-year contracts, which translates to over \$100,000 in contract sales. Within our sales team, we have a 100+ school pipeline.

Pilot Schools: We are "sponsoring" Y1 of the first 10 schools (pilots); on day one the 13th month, they will pay for 36 months due (of first 4 years of 8 year agreement). On day one of the 37th month, they will pay for an additional 48 months. If, thereafter, both parties have not requested termination, the agreement will come for review and then renewal. Each month, we will recognize \$182 in revenue per school.

For non-pilot schools, we will recognize \$208/month in revenue per school. We hope (but cannot guarantee) 48 more schools in 2020.

We also hope to start revenue from ads as viewers watching student videos. From that revenue stream, we are hoping for a monthly average of \$11,000 beginning June of 2020.

If we raise our maximum goal, we hope (but not guarantee) to have \$30,000 in sales/month and our expenses to be about \$72,000/month in approximately six months. We plan on raising capital again one month after the close of this offering. If need be, we can solicit our past accredited investors for additional capital.
