Popoca Oakland, LLC is an Oakland California based food service (NAICS 722310) that dishes out progressive Salvadoran food. **Popoca Oakland, LLC**'s mission is to find and preserve techniques from the past to bring you a new and authentic experience in Oakland. Inspired by traditional Salvadoran wood-fire cooking and recipes, Popoca Oakland, LLC offers dishes — like pupusas and tamales that use the freshest ingredients and fresh-milled masa. They are transitioning from a popup location into a full-service restaurant.

3. How will the issuer complete the transaction and deliver securities to the investors?

- 1) Offering Process The offering will use a first come first serve/pro-rata method to issue and sell bonds to investors. All bonds pay a fixed rate interest as per the terms of the offering.

They are transitioning from a popup location into a full-service restaurant.

Popoca Oakland, LLC had gross sales of \$154,017 in 2020. Gross profit margins were 72% in 2020.

Popoca Oakland, LLC intends to continue to grow its sales with expansion to a permanent location of its own. Further, Popoca Oakland, LLC will conduct a Regulation Crowdfunding offering on the SMBX platform, so as to engage with the community they serve by rewarding them with the financing profits that would otherwise go to the bank.


