### **Business and Anticipated Business Plan**

#### 6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Unum Health USA, Inc. ("Unum Health" or "Unum") is a software as a service ("SaaS") company designed with the specific needs of small- and medium-sized home care agencies in mind. Unlike complex electronic medical record ("EMR") technology, Unum plans to offer streamlined solutions tailored to fit the needs of growing agencies. With a user-friendly approach, Unum has two distinct interfaces: one for agency office teams and one for care workers out in the field. The Unum office user interface is intended to seamlessly manage all aspects of agency operations, from the onboarding of new clients to scheduling daily visits. Our platform integrates AI technology to streamline onboarding, billing, and scheduling processes. Our goal is to provide real-time visibility into client visits, with options for both online and offline access. For care workers, our interface provides convenient access to client information prior to each visit, and is intended to enhance the quality of care provided. With AI integration, our platform is designed to enhance security features during visits and provide geotagging functionality for location verification ("EVV") and accurate billing. Our goal is to enable care workers to focus on delivering quality care while our platform handles administrative tasks efficiently.

Unum currently has 1 employees.

## **Risk Factors**

- 1. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
- 2. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 3. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. However, implementing our business plan may require more employees, capital equipment, supplies

or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.

- 7. Third parties might infringe upon our technology. We cannot assure you that the steps we have taken to protect our property rights will prevent misappropriation of our technology. To protect our rights to our intellectual property, we plan to rely on a combination of trade secrets, confidentiality agreements and other contractual arrangements with our employees, affiliates, strategic partners and others. We may be unable to detect inappropriate use of our technology. Failure to adequately protect our intellectual property could materially harm our brand, devalue our proprietary content and affect our ability to compete effectively. Further, defending any technology rights could result in significant financial expenses and managerial resources.
- 8. The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. 15. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

- 17. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. ## **The Offering**

Unum Health USA, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$1,100,000 through an offering under Regulation CF. #### 10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Unum Health USA, Inc. must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

#### 11. How can an investor cancel an investment commitment?

Unum Health USA, Inc. ("Unum Health," "Unum," or the "Company") was incorporated on April 16, 2021 in the State of Delaware. Unum is a SaaS ("SaaS") company catering to small- and medium-sized home care agencies. The Company was designed to address the specific needs and challenges of these agencies without the complexity of traditional electronic medical record ("EMR") systems. Unum plans to offer two interfaces: one for agency office teams and another for care workers interacting with clients in the field. The Company is pre-revenue. Subsequent to the balance sheet date (March 31, 2023) and prior to the finalization of the financial statements, the Company incurred \$12,736 Canadian dollars in professional fees. \$2,676 Canadian dollars of this balance was paid by the Company's parent, Unum Health Inc., prior to the finalization of the financial statements, resulting in a balance due to the parent, with the remaining professional fees balance being due to the third-party vendor as of the date of finalization of the financial statements in development, marketing, and sales. We believe these activities will result in the traction we will need to court venture capital funding.
