Overview

The Company’s fiscal year-end is December 31.

Grizzlies LLC dba Pyro’s Pastrami (NAICS 722330) is a California based pop-up food and catering services that became an immediate hit when the social justice-minded company first began to "feed the revolution" in 2020. With over 6k followers on Instagram now, they are raising \$100,000 to outfit a brick-and-mortar delicatessen.

Grizzlies LLC began operations in July 2018. For FY21, the Company generated \$106,513 in revenue and \$17,164 of net income. During FY20 the Company generated \$26,443 in revenue and -\$3,373 of net income. These financial results are historical and not representative of what investors should expect in the future.

Milestones

Grizzlies LLC dba Pyro’s Pastrami was featured in the SF Chronicle. In May of 2021 after several articles and shoutouts by food curators, chefs, and other restaurant owners in the area, Pyro’s Pastrami filmed a short documentary with Vice’s Munchies that absolutely pushed their success through the roof.

Historical Results of Operations

- Revenues and gross margin. During FY20 and FY21, the Company generated revenues of \$26,443 and \$106,513, respectively, while gross margins were 56% and 56%, respectively. This reflected improvement despite the impact of the pandemic, which drove deterioration in demand for many companies in the same industry.
- Net income. For FY20 and FY21, the business generated earnings of -\$3,373 and \$17,164, respectively, as other income offset operational losses.
- Assets. Total assets changed from \$8,473 at year-end FY20 to \$91,018 at year-end FY21.
- Debt. Total debt was \$1,793 at year-end FY20 and \$90,489 at year-end FY21.


