If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. PennyFly Publishing LLC is a new company created on May 22, 2017. Since inception the company has been funded by capital contributions made by its members as well as a combination of PPP and third-party loans. During the last two fiscal periods the company was able to stay profitable by generating \$28,845 in net income during the year ended on 12/31/2020 and \$111,597 during the year ended on 12/31/2019. As a result of operations during the year ended on 12/31/2020, the company generated \$61,262 in revenue which represents approximately 58% decrease when compared with \$144,094 generated for the same period in 2019. During both periods all operating costs were attributed to general and administrative expenses. During 2020, the company entered into a PPP loan agreement with Wells Fargo bank in the amount of \$17,317. On April 26, 2021, the loan was fully forgiven. During 2021 the company was able to generate approximately \$73,000 in revenue from its standard services and approximately \$335,000 in revenues that were paid for via NFTs for its services provided to Dash League. Dash League is a game that allows users to mint ETH while playing the game. PennyFly is intimately involved in multiple elements of the game's (https://dashleague.io/) marketing, development, creative direction, and day to day operations. With this raise we plan to allocate funds to the RockAgainstTrafficking.org partnered "Set Them Free" album release campaign, featuring Slash, Fergie, Journey, Santana and others. We also plan to allocate funds towards advertising and legal expenses.
