Purpose of This Form

A company that wants to raise money using Regulation Crowdfunding must give certain information to prospective investors, so investors will have a basis for making an informed decision. (D) The Company's Business and Business Plan

Location

We are currently negotiating a space in West Ashley for our first location, and hope to open additional stores over the next 5 to 7 years. The citizens of and visitors to Charleston will benefit from a bagel bakery; we see a need waiting to be filled in a region that is rich with Jewish history, a rapidly growing population, and more than seven million annual visitors (pre-Pandemic) who create an annual economic impact of \$8.1+ billion. There is a lack of a superior bagelry in Charleston and our intent is to fill that niche with delicious foods served in a welcoming setting, with a focus on breakfast and lunch.

- Bettina Fisher is building a BAGELRY in the Charleston, SC area! Hello Lowcountry!
- We currently deliver wholesale bagels to Community Supported Grocery, a local CSA/artisanal delivery service. Additional customers are in the works.
- Blazing Star Cafe started as a part of the exploratory food court at The Workshop on Upper King Street, where it ran as a weekend pop-up from August 2020 to May 2021, an opportunity that provided time, space, and equipment to hone our recipes, refine menu selections, and develop a customer base.
- We will offer traditional bagels -- plain, sesame, onion, cinnamon raisin, and inside-out everything bagels -- and some more modern combos. Bialys will be in the rotation. We offer flavored cream cheeses such as scallion, veggie, and smoked salmon. The menu includes a

full complement of hot and cold drinks, including French Press coffee and cold brew from Springbok, hot tea & cold chai, and a dessert menu which changes seasonally, and which will always includes babka.

Our Mission

To become an integral part of the culinary and cultural Lowcountry landscape of Charleston, SC, filling an open market segment by creating high quality, locally produced bagels, and selling bagel sandwiches, beverages and related comestibles in a modern, well designed bagel bakery (or bagelry) and cafe.

Intended Use of Funds

An Investment of \$100,000 will secure:

- \$10,000 for equipment, including convection oven, bagel kettle, work tables, refrigeration and freezer space
- \$20,000 for part of the down payment on the lease of an existing location in West Ashley
- \$7,000 for tables, chairs, & shelves
- \$10,000 for deposits and insurance
- \$25,000 for graphic design, signage, marketing, website, menus & collateral material
- \$3,000 for legal, accounting & permits
- \$15,000 for demolition and painting the space
- \$10,000 to create a shaded outdoor patio and garden area

Bettina Fisher relocated to Charleston from Brooklyn, NY in 2013. Her experience encompasses many aspects of the food and beverage business, from catering, to fast casual, to fine dining. She has worked as a food stylist, a restaurant consultant, a writer, an event coordinator, a restaurant host and a kitchen manager. Blazing Star Cafe is her first solo business venture, which she began as a weekend stall at the exploratory food court at Workshop, in August 2020. She lives near Shem Creek, in Mt Pleasant.

Other Information on the Investment Process

- Investors may cancel an investment commitment until 48 hours prior to the Offering Deadline.
- MainVest will notify investors when and if the Target Offering Amount has been raised.
- If the Company reaches the Target Offering Amount before the Offering Deadline, it may close the offering early if it provides notice about the new Offering Deadline at least five business days before such new Offering Deadline, absent a material change that would require an extension of the offering and reconfirmation of the investment commitment.
- If an investor does not cancel an investment commitment before the 48-hour period before the Offering Deadline, the funds will be released to the Company upon closing of the offering and the investor will receive securities in exchange for his or her investment.

(K) Material Changes

In the event the issuer undergoes a material change, the Investor will be notified of such change. The investor will have five (5) business days from the receipt of such notice to reconfirm their investment. IF AN INVESTOR DOES NOT RECONFIRM HIS OR HER INVESTMENT COMMITMENT WITHIN FIVE (5) DAYS OF THE NOTICE OF MATERIAL CHANGE BEING SENT, THE INVESTOR'S INVESTMENT COMMITMENT WILL BE CANCELLED, THE COMMITTED FUNDS WILL BE RETURNED, AND THE INVESTOR WILL NOT BE ISSUED ANY OF THE SECURITIES REFERENCED IN THIS OFFERING.

Explanation

A “material change” means a change that an average, careful investor would want to know about before making an investment decision. If a material change occurs after you make an investment commitment but before the Offering closes, then the Company will notify you and ask whether you want to invest anyway. If you do not affirmatively choose to invest, then your commitment will be cancelled, your funds will be returned to you, and you will not receive any securities.

(L) Price of the Securities

The Company is offering “securities” in the form of revenue sharing notes, which we refer to as “Notes.” The Notes are being offered at their face amount. For example, you will pay \$1,000 for a Note with a face amount of \$1,000.

(M) Terms of the Securities

Overview

The Company is offering “securities” in the form of revenue sharing notes, which we refer to as the “Notes.” The Terms of the Notes are set forth in the Revenue Share Agreement accompanying this Form C in Appendix A. Copies of the Note and Revenue Sharing Agreement are attached to this Form C.

² The rate of revenue sharing is calculated on a linear scale with a minimum rate of 0.9% and a maximum rate of 4.5% and is rounded to the nearest 1/10th percent. The final rate is based on the amount raised and is calculated after the offering has successfully closed. As the amount raised in the offering increases, the rate of revenue sharing increases. For example, a hypothetical offering could result in the following revenue sharing percentages, depending on the amount raised:

³ To reward early participation, the investors who contribute the first \$10,000.0 raised in the offering will receive a 1.7x cap. Investors who contribute after \$10,000.0 has been raised in the offering will receive a 1.55x cap.

Your Right to Payments under the Note

Your right to payments under the Note is set forth in the Note, together with a separate document

called the Revenue Sharing Agreement. Copies of the Note and Revenue Sharing Agreement are attached to this Form C. Additionally, general terms are outlined below and in the Company's offering page.

Obligation to Contribute Capital

Once you pay for your Note, you will have no obligation to contribute more money to the Company, and you will not be personally obligated for any debts of the Company. However, under some circumstances you could be required by law to return some or all of a distribution you receive from the Company.

No Right to Transfer

You should plan to hold the Notes until maturity. The Notes will be illiquid (meaning you might not be able to sell them) for at least four reasons:

- The Revenue Sharing Agreement prohibits the sale or other transfer of Notes without the Company's consent.
- If you want to sell your Note the Company will have the first right of refusal to buy it, which could make it harder to find a buyer.
- Even if a sale were permitted, there is no ready market for Notes, as there would be for a publicly-traded stock.
- By law, for a period of one year you won't be allowed to transfer the Investor Shares except (i) to the Company itself, (ii) to an "accredited" investor, (iii) to a family or trust, or (iii) in a public offering of the Company's shares.

Security

The Notes are not secured by any assets of the Company or any assets of persons associated with the Company.

Modification of Terms of Notes

The terms of the Notes and the Revenue Sharing Agreement may be modified or amended with the consent of Investors holding 50% of the Notes, measured by the total amount outstanding under each Note.

Dilution of Rights

The Company has the right to create additional classes of securities, both equity securities and debt securities (e.g., other classes of promissory notes). Some of these additional classes of securities could have rights that are superior to those of the Notes. For example, the Company could issue promissory notes that are secured by specific property of the Company.

How the Exercise of Voting Rights Could Affect You

You will receive payments with respect to your Note only if the Company makes enough money to pay you, or, if the Company does not make enough money to pay you, if there is enough value in the collateral the Company pledged as security for the Notes.

The people with voting rights control the Company and make all the decisions about running its business. If they make good business decisions, it is more likely you will be paid. If they make poor business decisions, it is less likely you will be paid. For example, if they hire too many people and/or try to expand too quickly, the business could be harmed. The people with voting rights could also decide to file for bankruptcy protection, making it more difficult for you to be paid.

How the Notes are Being Valued

The Notes are being valued at their face value. We don't anticipate that we'll ever need to place a value on the Notes in the future.

(N) The Funding Portal

The Company is offering its securities through MainVest, Inc., which is a "Funding Portal" licensed by the Securities and Exchange Commission and FINRA. MainVest Inc.'s Central Index Key (CIK) number is 0001746059, their SEC File number is 007-00162, and their Central Registration Depository (CRD) number is 298384.

(O) Compensation of the Funding Portal

Upon successful funding of the Offering, the Funding Portal will receive as the "Revenue Securement Fee"; 3.0% of the amount of the Offering raised by First Time Users of the Platform plus 9.0% of the amount of the Offering raised by all other investors. "First Time Users" means a user of Mainvest.com who became a user only after the Offering was publicly listed on the Site.

(P) Indebtedness of the Company

The Company has no indebtedness outside of the debt the Company is expecting to raise through regulation crowdfunding on MainVest.

(Q) Other Offerings of Securities within the Last Three Years

The Company has not made any offerings with other third-party regulation crowdfunding companies in the past three years.

(R) Transactions Between the Company and “Insiders”

The Company has not entered into any business transactions, including stock Purchases, salaries, property rentals, consulting arrangements, guaranties, or other agreements with any individual identified in Section 227.201 (r)(1)-(4) of Regulation Crowdfunding during the 12 months preceding this Offering.

(S) The Company’s Financial Condition

The capital raised through Mainvest will make up the entirety of the Knead Dough LLC dba Blazing Star Bagels’s fundraising. However, Knead Dough LLC dba Blazing Star Bagels may require additional funds from alternate sources at a later date.
