All current employees have full-time jobs and are committed to working on Accrew outside of their current employment.

Accrew uses a lot of third-parties to facilitate servicing of the app and debit card program. Therefore, Accrew is subject to their terms, conditions, and service.

Not likely, but Accrew can run out of cash to service the app and upfront costs of the debit card program, thereby rendering Accrew bankrupt.

If there is no retail adoption of the Accrew platform, the company will incur \$65,000 of expenses for development, however, Accrew will seek to sell the platform to another company to recoup the losses.

A major technology malfunction or bug could cause users to lose trust in the banking platform and create a loss of demand for the product.

Fraud and security risks can be very detrimental to the business, with risk mitigation measures in place, the Web 3 components could provide additional risk.

Customer service will be a concern as the business scales from a couple thousand users to tens of thousands of users, especially when using a third-party and not necessarily have total control of the customer interaction.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Use of 7.5% is allocated to WeFunder and 92.5% will be allocated to Platform Proceeds: Development, including \$15K to set up the Bank Sponsorship & Payment Processor, \$10K to access MX technologies APIs, and \$21K to build the app with LoadSvs (Dev Shop).

If we raise: \$100,000

Use of 7.5% is allocated to WeFunder and 65% will be allocated to Platform Development, including \$15K to set up the Bank Sponsorship & Payment Processor, \$10K to access MX technologies APIs, and 40K to build the app with LoadSys (Dev Shop), Lastly, 20% will be allocated to Operational expenses and 7.5% to Marketing/Miscellaneous expenses.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving preferred stock, Investors will receive a number of shares of preferred stock calculated using the method that results in the greater number of preferred stock:

- i. the total value of the Investor's investment, divided by
 a. the price of preferred stock issued to new Investors multiplied by
 - b. the discount rate (85%), or
- ii. if the valuation for the company is more than \$1,250,000.00 (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the first \$50,000.00 of the securities, investors will receive a valuation cap of \$1,000,000.00 and a discount rate of 85.0%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an asconverted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**. Investors will receive

 proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

 Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock); ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and iii. Senjor to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

No preferred stock has been authorized. Investors in the SAFE, if converted, will receive preferred stock, which has liquidation preferences over common stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The shareholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. The shareholders have the right to redeem their securities at any time. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional stock, an Investor's interest will typically also be diluted.

Accrew aspires to have 2 million members/users while providing various financial services, including DeFi high-yield accounts through crypto staking, a crypto wallet, credit card, etc. Forward-looking projections are not guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

- Assets. For the short period ended February 28, 2022, the Company had total assets of \$8,200, including \$8,200 in cash. For the fiscal year ended December 31, 2021, the Company had total assets of \$0, including \$0 in cash.
- Net Loss. The Company has had net losses of \$924 for the short period ended February 28, 2022, and net losses of \$3,748 for the fiscal year ended December 31, 2021.
- Liabilities. The Company's liabilities totaled \$0 for the short period ended February 28, 2022 and for the 2021 fiscal year.

Liquidity & Capital Resources

To-date, the company has been financed with 4,672 in equity and 8,200 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 16 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 10 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Accrew, Inc. cash in hand is \$8,200, as of February 2022. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$500/month, for an average burn rate of \$500 per month. Our intent is to be profitable in 24 months.

An additional 400,000 shares of common stock have been issued. Outside of this, no other material changes in our finances or operations have occurred.

Accrew is currently developing the app with anticipated expenses for Platform Development, including \$15K to set up the Bank Sponsorship & Payment Processor, \$10K to access MX technologies APIs, and 40K to build the app with

LoadSys (Dev Shop).T Additionally, outside of the above-listed expenses, Accrew will maintain its current burn rate of \$500 a month totaling \$68,000 in expenses over the next 6 months. Accrew will not receive revenue until the app is finished, which is expected to be completed at the end of Q2 or sometime during Q3 of 2022. For the first year in operation, Accrew is projected to earn about \$91,000 in revenue.

Currently, Accrew is not profitable. Accrew is in the process of developing the app and debit card program. The platform will cost about \$65,000 to create and will start generating revenue when we go live in July, August, or September of 2022. During the first year, Accrew will be part of an accelerator program with Qolo, its payment processor, and will distribute all revenue to customers for profit-sharing. Accrew will not be profitable until the second year after raising funds from a Series A and becoming the program manager, thereby obtaining a majority of the revenue from interchange, interest margin, and ATMs.

We plan to use funds from our recent SAFE raise (\$8,200). The current business expenses are for email, domains, and miscellaneous expenses.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy").
