The majority of our customers are on Shopify and install our app through the Shopify App Store. As with all marketplace apps on any platform, there is always some amount of risk associated with that platform changing its terms and relationship with app developers.

We are building an ambitious application stack that will change how mid-market and enterprise eCommerce brands approach data collection, analysis, and activation. We're doing this in a largely "bootstrapped" fashion, with a low overall capital raise. This will allow us to hit profitability sooner and gives us more control over our roadmap, finances, etc. However, compared to the few larger players in our space, we're much less capitalized.

Internet privacy is a moving target, with countries and U.S. States enacting new privacy laws continually. We will have to continue to thread the needle, helping merchants respect privacy considerations, while helping the collect ist-party customer data. This challenge isn't unique to us, nor does the advent of new privacy laws mean that data collection is going away. Arguably, the tighter the laws around privacy, the more valuable our product becomes. But it should be understood that this is a dynamic space and time.

Fueled benefits from incredible engineering talent, much of which is located in Ukraine. While our developers in Ukraine are currently safe and available to work full-time, there is obviously a war in Ukraine that could impact the availability of certain members of the team.

Fueled is led by a small team of leaders in eCommerce analytics with unique skills and experience. There is risk to the company if Fueled's CEO or CTO were to exit, fall ill, or otherwise not be able to fulfill their duties for an extended period of time.

Much of what we are building will be open source. We believe this gives us a competitive advantage: We will benefit from a community of developers who will give back and offer us additional code and solutions. We will also have increased credibility, because we can "show our work." However, with any commercial open source project, competitors could leverage our own code in their competing applications.

The history of the open source movement suggests that this isn't typically an issue, and the benefits of open source outweigh the risks. But it should be understood that this is part of our business model.

As with all software products, there are business risks associated with changing technology landscapes (particularly in the realm of artificial intelligence), as well as malicious actors, such as viruses and hackers.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company, in such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possiblethat in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor's who holds an interest in the SPV, including each investor's texpaper identification number? ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (1) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalities that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.
