Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Jenni Earle is a maker of talismans for courage and authenticity, the foundation of which is our line of mantra-based bandanas. With a passion for ethical, domestic production, we make these talismans in the southeastern United States, from the cotton in the ground all the way through to the finished product. Our mission is to leave this world braver than we found it. By starting with and focusing on a niche product

that carried our mission-driven brand message so beautifully, we have been able to form relationships with domestic partners to assure that our transparent, domestic supply chain is true. This builds our customer's trust from the beginning. We have begun to deepen our relationships with other aligned textile companies as we scale. Building into the larger market of Ethical Fashion as we launch other products for revenue diversification, we plan to continue to partner with and amplify the sustainable innovations of the domestic textile ecosystem. These amazing companies need partnerships with consumer goods designers to bring their creations to life. By showing the wider fashion industry what is possible right here in the United States. Considering aesthetics, an essential value of a designer, so much of what we see in the transparent, ethical fashion world are muted-toned basics. Jenni Earle wants to empower the consumer of ethical fashion to add rich, style-forward accessories and garments to their closets while holding firm to their values.

Jenni Earle currently has 6 employees.

Risk Factors

7. Material factors that make an investment in Jenni Earle, Inc. speculative or risky:

1. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.

- 2. The Company may never receive a future equity financing, or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). If a liquidity event does not occur, such as a sale of the Company or an IPO, the purchasers could be left holding Company securities in perpetuity. The Company's securities have numerous transfer restrictions and will likely be highly illiquid, with potentially no secondary market on which to sell them. The securities have only a minority of voting rights and do not provide the ability to direct the Company or its actions.
- 3. In order to expand, the Company is raising funds, and may raise additional funds in the future, either by offerings of securities or through borrowing from banks or other sources. The terms of future capital raising, such as loan agreements, may include covenants that give creditors greater rights over the financial resources of the Company.
- 4. We are dependent on general economic conditions. Potential customers may be less willing to invest in innovation and forward-looking improvements if they are facing an economic downturn. This may temporarily reduce our market size. Furthermore, a global crisis might make it harder to diversify.
- 5. The Company has the right to extend the Offering deadline. The Company may extend the Offering deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the maximum offering amount even after the Offering deadline stated herein is reached. Your investment will not be accruing interest during this time and will simply be held until such time that Offering is closed, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you.
- 6. No governmental agency has reviewed the Company's offering and no state or federal agency has passed upon either the adequacy of the disclosure contained herein or the fairness of the terms of this offering.
- 7. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
- 8. The Company does not anticipate paying any cash dividends for the foreseeable future. The Company currently intends to retain future earnings, if any, for the foreseeable future, to repay indebtedness and to support its business. The Company does not intend in the foreseeable future to pay any dividends to holders of its shares of common stock.
- 9. The failure to attract and retain key employees could hurt our business, and our management does not have extensive experience in the operation of businesses such as ours. Our success also depends upon our ability to attract and retain numerous highly qualified employees. Our failure to attract and retain skilled management and employees may prevent or delay us from pursuing certain opportunities. If we fail to successfully fill many management roles, fail to fully integrate new members of our management team, lose the services of key personnel, or fail to attract additional qualified personnel, it will be significantly more difficult for us to achieve our growth strategies and success.
- 10. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
- 11. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.
- 12. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an

Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. Furthermore, the human and capital resources of the Company could be adversely affected by the need to defend actions under these laws, even if the Company is ultimately successful in its defense.

16. The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

18. The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. 20. The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

21. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

- 23. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. The Offering

Jenni Earle, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$1,069,999 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

The Company plans to use the funds from this Offering to increase inventory for current sales projections as well as allow the Company to partner with larger brands that ask for longer terms. This would include the purchase and activation of short-run in-house production equipment. This is expected to allow the Company to make and test new products for customers in a limited run capacity, allow customers to

customize their goods, as well as maintain the quality and creative intrigue that Jenni Earle has come to be known for. The Company is also aiming to increase spending on digital marketing. The Company has a strong brand story to tell and has been limited by capital restrictions. The Company's goal is to raise awareness of the brand's mission and values, which can turn bystanders into loyalists. An operational executive is needed on the team, as well as a digital marketing assistant and a design assistant. With strategic hiring, the Company can strengthen its in-house team for continued growth. This support would allow the founder to do more of what she needs to do to grow the brand, namely design, visioning and connecting with our community.

Financial Condition of the Issuer

Jenni Earle, Inc. (the "Company") formerly Jenni Earle, LLC reorganized as a North Carolina corporation August 5th, 2022. The Company is a maker of talismans for courage and authenticity, the foundation of

which is its line of mantra-based bandanas. Under the Company's articles of incorporation, the total number of shares the Company shall have the authority to issue is 10 million shares of common stock. As of the date of the filing of this offering, 6 million shares are currently issued and outstanding and 666,666 shares of common stock reserved under its Employee Option Pool. During 2022, the Company raised \$157,500 through a convertible note offering. Interest will accrue on the outstanding principal balance of each note from the date of the applicable closing at a rate of 6.00% per annum. The notes mature on May 31, 2027, and carry a \$3 million valuation cap. During 2022, the Company repaid in full the \$53,968 note payable that is listed on the Company's December 31, 2021 balance sheet. The Company's revenue streams have been derived from: (1) bandanas amounting to \$208,023 in 2021 and \$287,036 in 2020; (2) trophies amounting to \$80,009 in 2021 and \$110,399 in 2020; and (3) paper goods amounting to \$32,004 in 2021 and \$44,160 in 2020. In the year ended December 31, 2021, revenue amounted to \$320,036, while the cost of goods sold was \$154,580, resulting in a gross profit of \$165,456. For the same year, total operating expenses were \$197,757, which after other income and interest expenses resulted in a net loss of \$17,900. During the same year, the Company received \$28,968 via the issuance of note payables from which \$25,000 was contributed from a relative of the CEO via a related party loan. The Company also recorded \$3,229 of cash outflows via member draws on contributed capital. In the year ended December 31, 2020, revenue amounted to \$441,595, while the cost of goods sold was \$211,840, resulting in a gross profit of \$229,755. For the same year, total operating expenses were \$202,367, which after other income and interest expenses resulted in a net income of \$24,475. During the same year, the Company received \$37,860 via the issuance of note payables. The Company also recorded \$30,307 of cash outflows via member draws on contributed capital. With this raise, the Company plans to use the proceeds primarily for hiring staff, digital marketing, acquiring inventory, production equipment, developing new products, and compensation for managers.
