- APPRECIATION POTENTIAL The notes provide the opportunity to enhance equity returns by multiplying a positive Index Return by two, up to the Maximum Total Return on the notes of 20.25%, or \$1,202.50 for every \$1,000 principal amount note. The actual Maximum Total Return on the notes will be set on the pricing date and will not be less than 20.25%. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- LIMITED PROTECTION AGAINST LOSS Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to 10%\*\*. If the Ending Index Level declines by more than 10%\*\*, for every 1% decline of the Index beyond 10%\*\*, you will lose an amount equal to 1% of the principal amount of your notes. The S&P 500<sup>®</sup> Index consists of 500 component stocks selected to provide a performance benchmark for the U.S. equity markets. For additional information about the Index, see the information set forth under "The S&P 500<sup>®</sup> Index" in the accompanying product supplement no. 18-I.
- **CAPITAL GAINS TAX TREATMENT** You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 18-1. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Davis Polk & Wardwell, it is reasonable to treat your purchase and ownership of the notes as an "open transaction" for U.S. federal income tax purposes. This secondary market price will also be affected by a number of factors aside from the agent's commission and hedging costs, including those set forth under "Many Economic and Market Factors Will Impact the Value of the Notes" below.

- LACK OF LIQUIDITY The notes will not be listed on any securities exchange. JPMSI intends to offer to purchase the notes in the secondary market but is not required to do so. The hypothetical total returns set forth below assume an Initial Index Level of 1350, a Maximum Total Return on the notes of 20.25% and a Buffer Amount of 10%. Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table on the previous page are calculated.

**Example 1: The level of the Index increases from the Initial Index Level of 1350 to an Ending Index Level of 1417.50.** Because the Ending Index Level of 1417.50 is greater than the Initial Index Level of 1350 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 20.25%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

#### \$1,000 + [\$1,000 x (5% x 2)] = \$1,100

**Example 2: The level of the Index decreases from the Initial Index Level of 1350 to an Ending Index Level of 1215.** Because the Ending Index Level of 1215 is less than the Initial Index Level of 1350 by not more than the hypothetical Buffer Amount of 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

**Example 3: The level of the Index increases from the Initial Index Level of 1350 to an Ending Index Level of 1620.** Because the Ending Index Level of 1620 is greater than the Initial Index Level of 1350 and the Index Return of 20% multiplied by 2 exceeds the hypothetical Maximum Total Return of 20.25%, the investor receives a payment at maturity of \$1,202.50 per \$1,000 principal amount note, the maximum payment on the notes.

**Example 4: The level of the Index decreases from the Initial Index Level of 1350 to an Ending Index Level of 1080.** Because the Ending Index Level of 1080 is less than the Initial Index Level of 1350 by more than the hypothetical Buffer Amount of 10%, the Index Return is negative and the investor receives a payment at maturity of \$900 per \$1,000 principal amount note, calculated as follows:

#### \$1,000 + [\$1,000 x (-20% + 10%)] = \$900

**Example 5: The level of the Index decreases from the Initial Index Level of 1350 to an Ending Index Level of 0.** Because the Ending Index Level of 0 is less than the Initial Index Level of 1350 by more than the hypothetical Buffer Amount of 10%, the Index Return is negative and the investor receives a payment at maturity of \$100 per \$1,000 principal amount note, which reflects the principal protection provided by the Buffer Amount of 10%, calculated as follows:
