Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

SUMMARY NextPower360 is designing and commercializing a breakthrough wind generator that, unlike incumbent designs, is anticipated to efficiently harvest energy from fast wind, potentially doubling the output potential per wind turbine. THE PROBLEM THAT WE ARE SOLVING Wind turbines should produce the most power at high wind speeds, yet the current wind industry sees fast wind as a problem to be mitigated rather than an untapped resource. Every year, the wind industry fails to convert into electricity over \$10 billion dollars worth of wind energy that hits wind turbine blades. This unharvested power could supply all the annual electricity needs for New York City 13 times over. The problem gets worse. If the wind blows too fast, the generator and wind turbine can break. So, the high energy fast wind is not just untapped but intentionally wasted through built-in systems, such as mechanical breaking or turning airfoils away from the wind. Incumbent technology actually pirates some of the energy captured from medium-speed wind to slow down the turbine when the wind is blowing too fast. When Nikola Tesla invented his induction generator in the 1880s, he designed it to harvest energy from a steady source, such as steam or the run of a river. The generators inside today's wind turbine are descendants of Tesla's design, but wind is

anything but steady, so a percentage of potential wind is simply missed. Just like eating soup with a fork, the generators inside today's wind turbines are the wrong tool for the job. At NextPower360, we believe we have designed the generator that Tesla would have invented had he been tasked to harvest energy from a variable source of energy. SOLUTION NextPower360's generator is advancing the state of the art, by producing a generator that will continually and instantaneously adapt to the ever-changing wind and capture the maximal amount of harvestable power, even at fast wind speeds. NextPower360 design leverages the long-proven principles of Tesla's brilliant induction generator but has changed the generator topology and rearranged the magnets to work at maximum efficiency across a far wider spectrum of variable input demands. There are eight innovations in all that work in concert with each other including a breakthrough concentric stator configuration. Dr. Khalid Hamied, a Ph.D. in electrical engineering from Georgia Tech and technology advisor to Nextpower360, described our technological innovation this way: "This simple, out-of-the-box thinking resulted in a variable speed generator design that nobody had thought about before—genuinely hidden in plain sight. A novel design that, I believe, will revolutionize wind power generation." As motors and generators are essentially the same technology that operates in reverse of each other, our innovation applies to electric motors as well. The inventor, Dr. Tony Iacovelli, submitted his provisional patent application for his innovations that addresses both generators and motors on August 26, 2022. BENEFITS NextPower360 innovations have the potential to create the following benefits: • More Power. NextPower360's wind generator is anticipated to capture the wind's full power potential, including fast wind, which can double a wind turbine's power output at a lower levelized cost of energy. • Reduced Manufacturing Costs. Significant reductions in laminated steel in the stator core can reduce manufacturing costs. • Improved Cost Effectiveness. Anticipated significant reductions in the overall cost of energy, increasing the cost-effectiveness of wind farms and potentially strengthening their ROI. • Potential Carbon Reductions. Anticipated gigaton reductions of carbon emissions from the energy sector. • Better Siting Options. Expanding siting options for wind farms to be closer to where electricity is needed most, increasing site opportunities for wind, and reducing infrastructure costs such as roads and transmission lines. • Less Rare Earth Magnets. Reducing or even eliminating rare earth magnets in wind generators, reducing dependence on an environmentally risky and fragile supply chain. BUSINESS MODEL AND ACCOMPLISHMENTS The company is conducting R&D currently. Commercialization of the technology is planned for 2025. The company is planning to license its technology to major manufacturers in the wind industry and their suppliers. Our team has accomplished so much since the company launch in September of 2022, including: • Patent Process. Submitted our initial landmark provisional patent on August 26, 2022, including a 72-page technical disclosure document. • Proofs of Concept. Assembled first proofs of concept that demonstrate electricity production, intrinsic adaptability to a variable input, and a clean, radial magnetic field as anticipated by our design. • Key Advisors. Assembled an impressive Technology Board of Advisors. • Early Capital. Secured \$100,0000 in initial pre-seed funding. • Submitted a full federal Small Business Innovation Research (SBIR) grant application as part of our strategy to tap into unprecedented amounts of federal funds targeting low-carbon technologies. • Energy Labs. Explored collaboration with sophisticated energy labs in North Carolina, where we can continue our prototype development work. COMPANY VISION The vision of the NextPower360 team is ambitious. Our potentially disruptive technology has the potential to shape the wind and electric vehicles sectors, both of which are \$100 billion industries that are still growing quickly. The NextPower360 generators and motors have the potential to reduce gigatons of greenhouse gas emissions annually and may be one of the most significant emerging technology opportunities to enable humanity to rise to the challenge of climate change. The NextPower360 team believes that we are carrying Nikola Tesla's torch, as we strive towards creating a fundamental shift in the value equation for wind.

1. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business. If the Company's employees or employees of any of the Company's vendors, suppliers or customers become ill or are quarantined and in either or both events are therefore unable to work, the Company's operations could be subject to disruption. The extent to which a pandemic affects the Company's results will depend on future developments that are highly uncertain and cannot be predicted.
2. The Company may never receive a future equity financing, or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). If a liquidity event does not occur, such as a sale of the Company or an IPO, the purchasers could be left holding Company securities in perpetuity. The Company's securities have numerous transfer restrictions and will likely be highly illiquid, with potentially no secondary market on which to sell them. The securities have only a minority of voting rights and do not provide the ability to direct the Company or its actions.
3. In order to expand, the Company is raising funds, and may raise additional funds in the future, either by offerings of securities or through borrowing from banks or other sources. The terms of future capital raising, such as loan agreements, may include covenants that give creditors greater rights over the financial resources of the Company.
4. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
5. Potential customers may be less willing to invest in innovation and forward-looking improvements if they are facing an economic downturn. This may temporarily reduce our market size. Furthermore, a global crisis might make it harder to diversify.
6. The Company may extend the Offering deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the maximum offering amount even after the Offering deadline stated herein is reached. Your investment will not be accruing interest during this time and will simply be held until such time that Offering is

closed, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you.

7. No governmental agency has reviewed the Company's offering and no state or federal agency has passed upon either the adequacy of the disclosure contained herein or the fairness of the terms of this offering.
8. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
9. The Company does not anticipate paying any cash dividends for the foreseeable future. The Company currently intends to retain future earnings, if any, for the foreseeable future, to repay indebtedness and to support its business. The Company does not intend in the foreseeable future to pay any dividends to holders of its shares of common stock.
10. The failure to attract and retain key employees could hurt our business, and our management does not have extensive experience in the operation of businesses such as ours. Our success also depends upon our ability to attract and retain numerous highly qualified employees. Our failure to attract and retain skilled management and employees may prevent or delay us from pursuing certain opportunities. If we fail to successfully fill many management roles, fail to fully integrate new members of our management team, lose the services of key personnel, or fail to attract additional qualified personnel, it will be significantly more difficult for us to achieve our growth strategies and success.
11. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if they fail to perform in their current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
12. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.
13. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. The Company may also only be obligated to file information periodically regarding its business, including financial statements. A publicly listed company, in contrast, is required to file annual and quarterly reports and promptly disclose certain events — through continuing disclosure that you can use to evaluate the status of your investment.

16. *The U.S. Securities and Exchange Commission does not pass upon the merits of any securities offered or the terms of the offering, nor does it pass upon the accuracy or completeness of any offering document or literature.*

You should not rely on the fact that our Form C, and if applicable Form D is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering.

17. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. Furthermore, the human and capital resources of the Company could be adversely affected by the need to defend actions under these laws, even if the Company is ultimately successful in its defense.

18. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. 19. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the

Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

20. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. It is not currently contemplated that registration under the Securities Act or other securities laws will be affected. 22. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

23. *The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors.
