6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

BeONE Sports has developed cutting-edge, sports training technology based on body mechanics within any sport. We have developed "Comparative Training," where accomplished athletes' movements are digitized into our technology, creating a catalog of varying skill levels and styles to learn from. Using a mobile device, athletes around the world can train with their heroes. Athletes, coaches, and parents receive immediate feedback on technique and body-position improvements. The Company's Comparative Training approach utilizes "on-field" artificial intelligence that provides data for athletes, coaches, and trainers. Additionally, the company has created a marketplace that is innovative in the name, image, and likeness ("NIL") space. It provides college athletes the opportunity to earn revenue by simply practicing their sport and uploading their comparative. The Company's platform provides exposure to a global audience for athletes to demonstrate their ability using verified data. There is a growing "pay to play" phenomenon in sports, and, to our knowledge, there is no affordable or widely accessible solution for specialized sports training. Specialized training plays a critical role to maximize potential in competitive sports. Whether you are working with a well-known coach or using the latest technology, advanced training is necessary to reach the next level. However, access to specialized training is very limited. Everything from finding and connecting with the coach, traveling and meeting for training, and paying high costs, are all restricting factors. Comparative training allows athletes to train themselves to prior versions of themselves, or to other athletes with more developed form and technique. As all humans are unique, BeONE Sports provides "comparative matching" which is driven from a catalog of athletic styles, body dimensions, and skill levels, to find recommended training comparatives. It is a new approach designed to complement the legacy of coaching experience with data-driven insight. - 2. The Name, Image, Likeness ("NIL") era has reshaped collegiate sports, and remains an ever-changing legislative exercise. While the current environment is trending toward additional student-athletes' rights and clear activity embracing the concept of NIL in sports (indicated by through large investments at Universities to include NIL facilities, faculty and strategy), there is foreseen adjustments and clarity being offered by the NCAA, State and Federal bodies.
- 3. Our ability to succeed depends on how successful we will be in our fundraising effort. We plan to diversify fund-raising beyond this campaign, in order to use resources to build the necessary business infrastructure to be successful in the long-term. In the event of competitors being better capitalized than we are, that would give them a significant advantage in marketing and operations.
- 4. The Company may never receive a future equity financing or undergo a liquidity event such as a sale of the Company or an initial public offering, and you may not be able to sell any shares that you purchase in this offering. The Company may never receive a future equity financing, or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.
