6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

The Company plans to become a hospitality real estate developer, owner, and operator with a focused mission to create exceptional high-end wellbeing retreats in some of the most coveted Mediterranean locations. We are driven by a commitment to excellence in environmental responsibility and sustainable operations within the tourism industry. Our primary goal is to provide guests with an inclusive and transformative wellbeing experience that goes beyond the mere concept of "wellness." We aim to deliver luxury without compromising on our dedication to promoting guests' health and overall wellbeing. We strive to offer guests every opportunity to maintain their existing health goals while gently encouraging and supporting those considering health or lifestyle changes. Optimizing our guest's luxury holiday while prioritizing their well-being. To achieve this, our strategy is to continuously adopt leading trends, implement new programs, and collaborate with health-forward specialists to offer exclusive treatments and nourishing cuisine. By providing a holistic lifestyle opportunity, we plan to assist our guests in resetting or maintaining their health goals, promoting their overall wellbeing. Additionally, we are committed to

obtaining Green Key certification as an organization, demonstrating our dedication to meeting guests' expectations and making a positive impact on the environment. The Green Key certification program allows us to review and audit our sustainability goals, ensuring that we meet the highest standards in environmental stewardship. In terms of monetization, we plan to employ a combination of annual memberships and open guest bookings. Locally, we plan to generate revenue through a signature restaurant, our world-class spa facility, and the sale of products sourced from our own farming operations. Moreover, we anticipate we will provide guided local excursions and day trips to neighboring villages and other points of interest. Further to enhance guests' experience, we can offer access to play golf on Mallorca's finest courses, the option to hire a private yacht for a day of leisure, or a day's outing to nearby beach clubs.

2. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.
3. No governmental agency has reviewed the Company's offering and no state or federal agency has passed upon either the adequacy of the disclosure contained herein or the fairness of the terms of this Offering.
4. We are dependent on general economic conditions. Potential customers may be less willing to invest in innovation and technological improvements in an economic downturn. This may temporarily reduce our market size.
5. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted.
6. Our future growth depends on our ability to develop and retain customers. Our future growth depends to a large extent on our ability to effectively anticipate and adapt to customer requirements and offer

- services that meet customer demands. If we are unable to attract customers and/or retain customers, our business, results of operations and financial condition may be materially adversely affected.
7. Our ability to succeed depends on how successful we will be in our fundraising efforts. We rely on investment funds in order to use resources to build the necessary tech and business infrastructure to be successful in the long-term. Current and future competitors may be able to draw on substantially greater financial resources than those available to the Company to develop products that are easier to commercialize or become more popular with the potential consumers of our products.
  8. We face risks related to health epidemics and other outbreaks, which could significantly disrupt the Company's operations and could have a material adverse impact on us. The outbreak of pandemics and epidemics could materially and adversely affect the Company's business, financial condition, and results of operations. If a pandemic occurs in areas in which we have material operations or sales, the Company's business activities originating from affected areas, including sales, materials, and supply chain related activities, could be adversely affected. Disruptive activities could include the temporary closure of facilities used in the Company's supply chain processes, restrictions on the export or shipment of products necessary to run the Company's business, business closures in impacted areas, and restrictions on the Company's employees' or consultants' ability to travel and to meet with customers, vendors or other business relationships. The extent to which a pandemic or other health outbreak impacts the Company's results will depend on future developments, which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of a virus and the actions to contain it or treat its impact, among others. Pandemics can also result in social, economic, and labor instability which may adversely impact the Company's business.
  9. Your shares are not easily transferable. You should not plan on being able to readily transfer and/or resell your security. Currently there is no market or liquidity for these shares and the Company does not have any plans to list these shares on an exchange or other secondary market. At some point the Company may choose to do so, but until then you should plan to hold your investment for a significant period of time before a liquidation event occurs, if ever.
  10. The Company likely will not pay dividends for the foreseeable future. Unless otherwise specified in the offering documents and subject to state law, you are not entitled to receive any dividends on your interest in the Company. Accordingly, any potential investor who anticipates the need for current dividends or income from an investment should not purchase Securities in the Offering.
  11. You may only receive limited ongoing disclosure. While the Company must disclose certain information, since the Company is at an early stage, it is only able to provide limited information about its business plan and operations because it does not have fully developed operations or a long history. The Company may also only be obligated to file information periodically regarding its business, including financial statements. A publicly listed company, in contrast, is required to file annual and quarterly reports and promptly disclose certain events — through continuing disclosure that you can use to evaluate the status of your investment.
  12. The Company may never receive a future equity financing or undergo a liquidity event such as a sale of the Company or an initial public offering (IPO). The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. Furthermore, the human and capital resources of the Company could be adversely affected by the need to defend actions under these laws, even if the Company is ultimately successful in its defense.

16. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you. If the Company reaches the target offering amount prior to the Offering Deadline, they may conduct the first of multiple closings of the Offering prior to the Offering Deadline, provided that the Company gives notice to the investors of the closing at least five business days prior to the closing (absent a material change that would require an extension of the Offering and reconfirmation of the investment commitment). Thereafter, the Company may conduct additional closings until the Offering Deadline. The Company may also end the Offering early; if the Offering reaches its target offering amount after 21-calendar days but before the deadline, the Company can end the Offering with 5 business days' notice. 17. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

18. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities*

*regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. It is not currently contemplated that registration under the Securities Act or other securities laws will be affected. 20. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

21. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. Failure to obtain such financing on favorable terms could dilute or otherwise severely impair the value of the investor's Company securities.

22. *There is no present public market for these Securities and we have arbitrarily set the price.*

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

23. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the

Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Each prospective Investor is encouraged to carefully analyze the risks and merits of an investment in the Securities and should take into consideration when making such analysis, among other, the Risk Factors discussed above.

## The Offering

Believe Hotel Group US, Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$1,199,993 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

### 8. What is the purpose of this offering?

The funds raised through this offering will be allocated towards several key activities. Initially, a portion of the funds will be used to secure the acquisition of an 18th-century estate in Mallorca, Spain. This will be done through the issuance of a memorandum of understanding, which will include a refundable option/deposit. The company will then proceed with legal due diligence on the property, surveying the land and buildings, and creating the initial designs required for planning permission. The next step involves preparing the necessary documentation for planning permission and seeking approval for the renovation of the estate into a high-end boutique wellbeing retreat. It is important to note that the actual purchase of the property will only proceed once the company receives assurances that planning permission will be granted. In the event that planning permission is not obtained, the funds plan to be redirected towards an alternative property of similar assessment to serve as a backup option. Additionally, a portion of the raised funds aim to be allocated towards establishing the core infrastructure for the operating company. This includes setting up the necessary systems, processes, and resources to support the operations of the boutique wellbeing retreat. Furthermore, the company aims to utilize the funds to prepare and promote subsequent funding rounds, both in terms of equity and debt financing. These rounds aim to be crucial for mobilizing the full purchase and upgrade project, ensuring that the necessary financial resources are available to carry out the renovation and upgrade of the estate. In summary, the funds raised in this offering aim to be used to secure

the acquisition of the estate, conduct legal due diligence and surveying, obtain planning permission, establish the core infrastructure of the operating company, and promote additional funding rounds to support the full purchase and upgrade project. **10. How will the issuer complete the transaction and deliver securities to the investors?**

Believe Hotel Group US Inc. was incorporated on April 14, 2023, in the state of Delaware. The Company's headquarters are located in New York, New York. The Company is organized for the purpose of engaging in real estate investment activities, including but not limited to the acquisition, ownership, development, and management of hotel properties. The goal is to invest directly or indirectly in hotel properties around the world, initially in Spain, but eventually in Italy, Greece, and potentially more countries. Results of Operations: The Company was incorporated on April 14, 2023. As of the year ended September 30, 2023, the Company has not recorded any revenues or expenses. Liquidity & Capital Resources: On December 13, 2023, the Company drew down gross proceeds of \$11,214 in exchange for issuing 356 shares of common stock through a Reg CF offering. The offering is currently ongoing. As of the year ended September 30, 2023, the Company recorded cash of \$1,065 and working capital of \$1,065. The Company is responsible for securing part of the equity funding and ownership of our hospitality stable in the Mediterranean. We are excited to present an investment opportunity in BELIEVE BELTANE SL, a limited company to be registered in Spain. Our plan is to acquire a carefully selected hospitality real estate asset and transform it into a high-end boutique hotel and wellbeing retreat; simultaneously re-establishing the agricultural operation (vineyards, olive, and carob groves). To bring this vision to life, BELIEVE BELTANE SL projects is will require €30 million (\$32.2 million) to achieve operational and revenue status. The planned financing structure is detailed as follows: The investment funds plan to be allocated against various aspects of the project, including property acquisition, design development, renovation, and refurbishment, plus regeneration of the agricultural operations. By strategically investing in these key areas, we aim to immediately enhance asset value, while providing a revenue stream through hotel operations, unlocking long-term potential. In the Seed Round, we plan to sell 38,095 shares at a price of \$31.50 each through the Netcapital funding portal, resulting in a total raise of approximately \$1,200,000. The cost of capital for this round is expected to amount to approximately \$90,000. The primary objective of this round plans to be property development. In addition to the above, the company aims to secure European property loan financing of €12 million (\$12.9 million) with an expected flexible annual interest rate of 6.5%. Finally, BELIEVE BELTANE SL aims to utilize a financing round to raise €6 million (\$6.4 million). The capital raised through this round aims to be allocated towards property development, as well as launching the project and covering operating working capital needs.
