The company's use of the Sunn brand and logo is controlled by a licensing agreement. Should that licensing agreement be terminated or restricted, we may lose the rights to use the brand name on our products which may negatively affect our revenue.

Our business depends on a supply chain of raw materials to build our products. Geopolitical and macroeconomic conditions such as wars, natural disasters, pandemics, and similar events may disrupt the supply chain limiting our ability to manufacture products and negatively affecting our revenue.

The company might provide prospective investors with financial projections. The projections are estimates based on information available at the time. The company's actual financial results may be significantly different from our projections.

Any defects in the products we manufacture howsoever caused may result in returns, delays, or reduced or canceled customer orders which may negatively affect our revenue.

We may be subject to income taxes as well as non-incomebased taxes, such as payroll, sales, use, value-added, property, and goods and services taxes in the states and countries in which we operate. Changes in laws or regulations may result in new or increased taxes or loss of tax deductions that could negatively affect our profitability.

If the company is found to infringe on others intellectual property rights, regardless of whether it can develop non-infringing technology, it may be required to pay damages or royalties to a third party, or it may be subject to a temporary or permanent injunction prohibiting us from selling certain products. Litigation associated with intellectual property rights claims is expensive and time-consuming and may negatively affect our ability to manufacture and sell both existing and new products. Costs associated with litigation including legal fees and travel costs in addition to the costs of any penalties, royalties, or judgments against us and the loss of revenue from any prohibition of sales may significantly negatively affect revenue and profitability, and in some cases may be sufficient to cause the company to cease operations entirely.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Class A Common Stock shall have exclusive voting rights on all matters requiring the vote of the shareholders and the Class B Common Stock shall have no voting rights except as otherwise provided by law. Preferred Stock has a liquidation preference over Common Stock.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there

is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The shareholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Shareholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company, Investors' exit may affect the value of the Company and/or its viability.
