Our attorneys set up Flutterpads with Daniel Ameer being the 100% shareholder as a defacto "place holder" while the official cap table is formalized. The ownership reflected in this Form C is what we anticipate the ownership will be after this transition, however, this is subject to change.

The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Overview

A flexible extended-stay rental marketplace backed by its own properties.

#### Milestones

Flutterpads Inc. was incorporated in the State of Delaware in September 2023. Adaptive Capital Corporation was the predecessor company that was founded in 2015. Adaptive Capital Corporation pivoted from being in the real estate construction and development business to an extended-stay rental business in the second quarter of 2022, when FlutterPads began operating without officially incorporating. In September 2023, Flutterpads, Inc was incorporated and the business began operating through Flutterpads, Inc.

Since then, we have:

- \$11 million in assets under management and \$700k in annualized revenue within the first 18 months\*
- 85% occupancy rate, 100% satisfaction for value, location, and service quality per internal metrics
- We build, manage, buy/sell units while offering a membership-based online rental marketplace.
- Rental marketplace website and iOS/Android apps are scheduled to be live by May 15, 2024.

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

#### Historical Results of Operations

Our company was organized in September 2023 and has limited operations upon which prospective investors may base an evaluation of its performance.

- Revenues & Gross Margin. For the period ended December 31, 2023, the Company had revenues of \$1,884,231.36. Our gross margin was 56.85%. For the period ended December 31, 2022, the Company had revenues of \$1,347,981.04. Our gross margin was 45%.
- Assets. As of December 31, 2023, the Company had total assets of \$10,422,685.55, including \$186,241.75 in cash. As of December 31, 2022, the Company had total assets of \$9,876,850, including \$93,527 in cash.
- Net Income. The Company has had net income of \$264,345.89 for 2023 and net income of \$1,493.50 for 2022.
- Liabilities. The Company's liabilities totaled \$10,941,643.75 for 2023 and \$10,510,090.45 for 2022.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$4,950,000 in debt and \$250,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Flutterpads Inc. cash in hand is \$312,073.23, as of May 2024. Over the last three months, revenues have averaged \$42,000/month, cost of goods sold has averaged \$18,000/month, and operational expenses have averaged \$36,000/month, for an average burn rate of \$12,000 per month. Our intent is to be profitable in 18 months.

Since the date our financials cover, approximately \$700,000 in senior secured real estate debts have reached maturity and needs to be either paid off or refinanced. In 2022 the company transitioned from Adaptive Capital (focused on developing and selling real estate) to FlutterPads' new hospitality business model took place. Adaptive Capital no longer sold the inventory of developed real estate that it had normally sold each year in the past that would be reflected in the Gross Revenues. Instead, with the inception of the FlutterPads asset holding and rental model, only rental revenues and consulting revenues are the primary sources of income with no asset sales. In summary, 2022 was the year of FlutterPads inception (although not officially incorporated until 2023) and transition of Adaptive Capital's business model.

Over the next 3-6 months, we expect approximately \$74k/month in expenses. \$44k/month in recurring rental revenues, and incoming construction project revenues of \$650k that will be billed in 3 quarterly installments beginning April

We are not currently profitable. We are currently at a Net Loss of about 8.5% in relation to our Gross Revenues. With \$10 million in total funding, which is expected by the end of 2024, we anticipate approximately \$2.2 million Net Profit in 2025 with approximately 40% growth in underlying NAV. The primary source of net losses are stemming from Interest Expenses associated with our construction/development and portfolio building activities that have been impacted by the recent 20 months of rising interest rates. A strategic allocation of each round of funding will go towards retiring selected high interest loans and Construction Lines of Credits with approximately 43% reduction in Interest Expenses.

Besides funds raised through Wefunder, other sources of capital include: property refinancing transaction with access to equity, existing Internal Angel Investors who have funded the company in the past with private notes, advances from clients on Accounts Receivable, and sales of any underperforming assets.

All projections in the above narrative are forward-looking and not guaranteed.
