If you are relying on Note 1 to Rule 3-10(f), please ensure that all required narrative disclosure is included in the notes to the financial statements. Please advise us how you intend to comply with Rule 3-10.

We remind you that the company and its management are responsible for the accuracy and adequacy of their disclosures, notwithstanding any review, comments, action or absence of action by the staff.
