Item 7.01 Regulation FD Disclosure.

I. Price Risk Management

With the objective of enhancing the certainty of future revenues, from time to time EOG Resources, Inc. (EOG) enters into New York Mercantile Exchange related financial commodity collar and price swap contracts. In addition to these financial transactions, EOG is a party to various physical commodity contracts for the sale of hydrocarbons that cover varying periods of time and have varying pricing provisions. The financial impact of these various physical commodity contracts is included in revenues at the time of settlement, which in turn affects average realized hydrocarbon prices.

II. 2005 Fourth Quarter Financial Commodity Contracts

For the fourth quarter of 2005, EOG anticipates a gain of \$11.4 million from mark-tomarket financial commodity collar and price swap contracts compared to a gain of \$2.8 million for the prior year period. During the fourth quarter of 2005, there was no cash realized related to financial commodity contracts compared to a net cash outflow related to settled natural gas financial collar contracts, premium payments associated with certain natural gas financial collar contracts and settled natural gas financial price swap contracts of \$12.7 million for the prior year period.

III. 2006 Natural Gas Financial Collar Contracts and Natural Gas Financial Price Swap Contracts

(a) Natural Gas Financial Collar Contracts

Since EOG filed its Quarterly Report on Form 10-Q on November 1, 2005, EOG has entered into natural gas financial collar contracts covering notional volumes of 50,000 million British thermal units per day (MMBtud) for the period February 2006 through August 2006 at an average floor price of \$11.06 per million British thermal units (MMBtu) and an average ceiling price of \$13.63 per MMBtu. EOG accounts for these financial collar contracts using the markto-market accounting method.

(b) Natural Gas Financial Price Swap Contracts

Since EOG filed its Quarterly Report on Form 10-Q on November 1, 2005, EOG has entered into natural gas financial price swap contracts covering average notional volumes of 46,630 MMBtud for the period March 2006 through August 2006 at an average price of \$10.36 per MMBtu. EOG accounts for these financial price swap contracts using the mark-to-market accounting method.

(c) Presented below is a summary of EOG's 2006 natural gas financial collar and price swap contracts as of January 6, 2006.
