The Securities

These Dual Directional Barrier Notes may be suitable for investors who believe that the Reference Asset will increase or decrease moderately over the term of the Notes. So long as the Triger Event does not occur and the Reference Return of the Least Performing Underlying is less than its Initial Level, the securities will outperform the Reference Return of Reference Asset.

If the Final Level of each Underlying is greater than its Initial Level, you will realize a return equal to 122.50% of the Reference Asset appreciation (subject to the credit risk of HSBC). Information About the Underlyings

The S&P 500® Index

The SPX is a capitalization-weighted index of 500 U.S. stocks. It is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

The top 5 industry groups by market capitalization as of May 29, 2020 were: Information Technology, Health Care, Communication Services, Consumer Discretionary and Financials.




The Dow Jones Industrial Average®

The INDU is a price-weighted index compromised of 30 blue chip stocks considered to be the leaders in their industry. These pricing models consider certain assumptions and variables, which can include volatility and interest rates. Different pricing models and assumptions could provide valuations for the securities that are different from our Estimated Initial Value. These pricing models rely in part on certain forecasts about future events, which may prove to be incorrect. Example 1: The Final Level of the Least Performing Underlying is greater than its Initial Level.

Underlying	Initial Level	Final Level
SPX	1,000.00	1,500.00 (150% of its Initial Level)
INDU	1,000.00	1,100.00 (110% of its Initial Level)
NDX	1,000.00	1,800.00 (180% of its Initial Level)

INDU is the Least Performing Underlying. Because the Initial Level of INDU is 1,000.00 and the Final Level of INDU is 1,100.00, the Reference Return of the Least Performing Underlying is 10%, calculated as follows:

$$(1,100.00 - 1,000.00) / 1,000.00 = 10\%$$

Because the Reference Return of the Least Performing Underlying is positive, the Final Settlement Value would be \$1,122.50 per \$1,000 Principal Amount of the securities, calculated as follows:

\$1,000 + (\$1,000 x Reference Return of the Least Performing Underlying x Upside Participation Rate)

$$= $1,000 + ($1,000 \times 10.00\% \times 122.50\%)$$

= \$1,122.50

Example 2: The Final Level of the Least Performing Underlying is less than its Initial Level but a Trigger Event does not occur.

Underlying	Initial Level	Final Level

INDU	1,000.00	800.00 (80% of its Initial Level)
NDX	1,000.00	1,500.00 (150% of its Initial Level)

INDU is the Least Performing Underlying. Since the Final Level of INDU is not below its Trigger Level, a Trigger Event does not occur. Because the Initial Level of the INDU is 1,000.00 and the Final Level of INDU is 800.00, the Reference Return of the Least Performing Underlying is -20.00%, calculated as follows:

$$(800.00 - 1,000.00) / 1,000.00 = -20.00\%$$

Because the Final Level of the Least Performing Underlying is less than its Initial Level but equal to or greater than its Trigger Level, the Final Settlement Value would be \$1,200.00 per \$1,000 Principal Amount of the securities, calculated as follows:

\$1,000 + (\$1,000 × Absolute Reference Return of the Least Performing Underlying × Absolute Return Participation Rate)

$$= $1,000 + ($1,000 \times 20.00\% \times 100\%)$$

= \$1,200.00

Example 3: The Final Level of the Least Performing Underlying is less than its Trigger Level and a Trigger Event occurs.

Underlying	Initial Level	Final Level
SPX	1,000.00	800.00 (80% of its Initial Level)
INDU	1,000.00	500.00 (50% of its Initial Level)
NDX	1,000.00	1,000.00 (100% of its Initial Level)

INDU is the Least Performing Underlying. Since the Final Level of INDU is less than its Trigger Level, a Trigger Event occurs.

Because the Initial Level of INDU is 1,000.00 and the Final Level of INDU is 500.00, the Reference Return of the Least Performing Underlying is -50.00%, calculated as follows:

$$(500.00 - 1,000.00) / 1,000.00 = -50.00\%$$

Because the Reference Return of the Least Performing Underlying is less than -30%, the Final Settlement Value would be \$500.00 per \$1,000 Principal Amount of the securities, calculated as follows:

$$= $1,000 + ($1,000 \times -50.00\%)$$

= \$500.00





There is no direct legal authority as to the proper tax treatment of the securities, and therefore significant aspects of the tax treatment of the securities are uncertain as to both the timing and character of any inclusion in income in respect of the securities. Under one approach, a security should be treated as a pre-paid executory contract with respect to the Underlyings. We intend to treat the securities consistent with this approach. Pursuant to the terms of the securities, you agree to treat the securities under this approach for all U.S. federal income tax purposes. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special U.S. tax counsel, Mayer Brown LLP, it is reasonable to treat a security as a pre-paid executory contract with respect to the Underlyings. Pursuant to this approach, we do not intend to report any income or gain with respect to the securities prior to their maturity or an earlier sale or exchange and we intend to treat any gain or loss upon maturity or an earlier sale or exchange as long-term capital gain or loss, provided that you have held the security for more than one year at such time for U.S. federal income tax purposes.

We will not attempt to ascertain whether any of the entities whose stock is included in any Underlying would be treated as a passive foreign investment company ("PFIC") or United States real property holding corporation ("USRPHC"), both as defined for U.S. federal income tax purposes. If one or more of the entities whose stock is included in an Underlying were so treated, certain adverse U.S.

federal income tax consequences might apply. You should refer to information filed with the SEC and other authorities by the entities whose stock is included in the Underlyings and consult your tax advisor regarding the possible consequences to you if one or more of the entities whose stock is included in an Underlying is or becomes a PFIC or a USRPHC.

Under current law, while the matter is not entirely clear, individual non-U.S. holders, and entities whose property is potentially includible in those individuals' gross estates for U.S. federal estate tax purposes (for example, a trust funded by such an individual and with respect to which the individual has retained certain interests or powers), should note that, absent an applicable treaty benefit, the securities are likely to be treated as U.S. situs property, subject to U.S. federal estate tax. These individuals and entities should consult their own tax advisors regarding the U.S. federal estate tax consequences of investing in the securities.

A "dividend equivalent" payment is treated as a dividend from sources within the United States and such payments generally would be subject to a 30% U.S. withholding tax if paid to a non-U.S. holder. Under U.S. Treasury Department regulations, payments (including deemed payments) with respect to equity-linked instruments ("ELIs") that are "specified ELIs" may be treated as dividend equivalents if such specified ELIs reference an interest in an "underlying security," which is generally any interest in an entity taxable as a corporation for U.S. federal income tax purposes if a payment with respect to such interest could give rise to a U.S. source dividend. However, Internal Revenue Service guidance provides that withholding on dividend equivalent payments will not apply to specified ELIs that are not delta-one instruments and that are issued before January 1, 2023. Based on the Issuer's determination that the securities are not "delta-one" instruments, non-U.S. holders should not be subject to withholding on dividend equivalent payments, if any, under the securities. However, it is possible that the securities could be treated as deemed reissued for U.S. federal income tax purposes upon the occurrence of certain events affecting an Underlying or the securities, and following such occurrence the securities could be treated as subject to withholding on dividend equivalent payments. Non-U.S. holders that enter, or have entered, into other transactions in respect of an Underlying or the securities should consult their tax advisors as to the application of the dividend equivalent withholding tax in the context of the securities and their other transactions. If any payments are treated as dividend equivalents subject to withholding, we (or the applicable paying agent) would be entitled to withhold taxes without being required to pay any additional amounts with respect to amounts so withheld.
