

Based on the Worst Performing of the Common Equity Securities of Apple, Inc., Alphabet Inc. and Microsoft Corporation Principal at Risk Securities

The Contingent Income Auto-Callable Securities due July 24, 2024 Based on the Worst Performing of the Common Equity Securities of Apple, Inc., Alphabet Inc. and Microsoft Corporation, which we refer to as the securities, provide an opportunity for investors to earn a contingent quarterly payment at an annual rate of 8.30% of the stated principal amount with respect to each quarterly determination date on which the determination closing price or the final share price, as applicable, of each underlying is greater than or equal to its downside threshold level. The contingent quarterly payment, if any, will be payable quarterly on the contingent payment date (which is the third business day after the related determination date) or the maturity date, as applicable. It is possible that the closing price of one or more underlyings could remain below their respective downside threshold levels for extended periods of time or even throughout the term of the securities so that you may receive few or no contingent quarterly payments.

If the determination closing price of each underlying is greater than or equal to its initial share price on any of the second through eleventh determination dates, the securities will be automatically redeemed for an early redemption payment equal to the stated principal amount plus the contingent quarterly payment with respect to the related determination date. If the securities have not previously been redeemed and the final share price of each underlying is greater than or equal to its downside threshold level, the payment at maturity will be the stated principal amount and, the contingent quarterly payment with respect to the final determination date. If the securities have not been previously redeemed and the final share price of the worst performing underlying is less than its downside threshold level, but greater than or equal to its principal barrier level, the payment at maturity will be the stated principal amount and previously been redeemed and the final share price of any underlying is less than its principal barrier level, investors will be exposed to the decline in the closing price of the worst performing underlying, as compared to its initial share price, on a 1 to 1 basis and will receive a payment at maturity that is less than 65.00% of the stated principal amount of the securities and could be zero. Key Investment Rationale

The securities offer investors an opportunity to earn a contingent quarterly payment at an annual rate of 8.30% of the stated principal amount with respect to each determination date on which the determination closing price or the final share price, as applicable, of **each** underlying is greater than or equal to its downside threshold level. The securities may be redeemed prior to maturity for the stated principal amount per security *plus* the applicable contingent quarterly payment, and the payment at maturity will vary depending on the final share price of the worst performing underlying, as follows:


Scenario 1	On any of the second through eleventh determination dates, the determination closing price of <i>each</i> underlying is greater than or equal to its initial share price.
	The securities will be automatically redeemed for (i) the stated principal amount <i>plus</i> (ii) the contingent quarterly payment with respect to the related determination date.
	Investors will not participate in any appreciation of the underlyings from their respective initial share prices.
Scenario 2	The securities are not automatically redeemed prior to maturity and the final share price of each underlying is greater than or equal to its downside threshold level.
	The payment due at maturity will be (i) the stated principal amount <i>plus</i> (ii) the contingent quarterly payment with respect to the final determination date.
	Investors will not participate in any appreciation of the underlyings from their respective initial share prices.
Scenario 3	The securities are not automatically redeemed prior to maturity and the final share price of the worst performing underlying is <i>less than</i> its downside threshold level, but <i>greater than</i> or equal to its principal barrier level.
	The payment due at maturity will be the stated principal amount.
Scenario 4	The securities are not automatically redeemed prior to maturity and the final share price of <i>any</i> underlying is <i>less than</i> its principal barrier level.
	The payment due at maturity will be (i) the stated principal amount multiplied by (ii) the share performance factor of the worst performing underlying.
	Investors will lose a significant portion, and may lose all, of their principal in this scenario.




How the Securities Work

Diagram #1: Second through eleventh Determination Dates




Compare the determination closing price of each underlying against its initial share price and its downside threshold level until the final determination date or any earlier redemption.

Hypothetical Examples

The below examples are based on the following terms:

Hypothetical Initial Share Price:	With respect to each underlying, \$100.00
Hypothetical Downside Threshold Level:	With respect to each underlying, \$75.00, which is 75.00% of its hypothetical initial share price
Hypothetical Principal Barrier Level:	With respect to each underlying, \$65.00, which is 65.00% of its hypothetical initial share price
Hypothetical Contingent Quarterly Payment:	8.30% per annum (corresponding to \$0.2075 (or 2.075%) per quarter per security)
Stated Principal Amount:	\$10 per security

In Examples 1 and 2, the closing prices of the underlyings fluctuate over the term of the securities and the determination closing price of **each** underlying is greater than or equal to its hypothetical initial share price on one of the second through eleventh determination dates. Because the determination closing price of **each** underlying is greater than or equal to its initial share price on one of the second through eleventh determination dates, the securities are automatically redeemed following the relevant determination date. In Examples 3 and 4, the determination closing price of at least **one** underlying on the second through eleventh determination dates is less than its initial share price, and, consequently, the securities are not automatically redeemed prior to, and remain outstanding until, maturity.

* The early redemption payment includes the unpaid contingent quarterly payment with respect to the determination date on which the determination closing price of each underlying is greater than or equal to its initial share price and the securities are redeemed as a result.

In Example 1, the securities are automatically redeemed following the second determination date as the determination closing price of each underlying on the second determination date is greater than or equal to its initial share price. You would receive the early redemption payment, calculated as follows:

stated principal amount + contingent quarterly payment = \$10 + \$0.2075 = \$10.2075

In this example, the early redemption feature limits the term of your investment to approximately 3 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly payments.

In Example 2, since the determination closing price of each underlying on the 1st determination date is greater than its downside threshold level, you would receive the contingent payment of \$0.2075 with respect to that determination date. You would receive no contingent payment with respect to the 2nd through 10th determination dates, since the determination closing price of at least one underlying on each of those determination date is less than its downside threshold level. The securities are automatically redeemed following the 11th determination date, as the determination closing price of each underlying on that day is greater than or equal to its initial share price. Following the 11th determination date, you would receive an Early Redemption Payment of \$10.2075, which includes the contingent quarterly payment with respect to the 11th determination date.

In this example, the early redemption feature limits the term of your investment to approximately 33 months and you may not be able to reinvest at comparable terms or returns. If the securities are redeemed early, you will not receive any additional contingent quarterly

payments. Further, although the worst performing underlying has appreciated by 5% from its initial share price as of the 11 th
determination date, you only receive a total payment of \$10.2075 per security and do not benefit from such appreciation.

Examples 3 and 4 illustrate the payment at maturity per security based on the final share price of the worst performing underlying.

In Example 3, the closing price of at least one underlying is below its principal barrier level on every determination date. As a result, you would not receive any contingent quarterly payments during the term of the securities and, at maturity, you would be fully exposed to the decline in the closing price of the AAPL, which is the worst performing underlying. As the final share price of the worst performing underlying is less than its principal barrier level, your payment at maturity is calculated as follows:

Payment at maturity = $\frac{\text{final share price of AAPL}}{\text{initial share price of AAPL}} \text{ x principal amount} = \frac{\$50.00}{\$100.00} \text{ x \$10.00} = \$5.00$

In this example, the payment you would receive at maturity is significantly less than the stated principal amount. In addition, you would not be entitled to receive any contingent quarterly payments during the term of the securities.

In Example 4, the closing price of at least one underlying is below its downside threshold level on each of the 1st through the 11th determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final share price of each underlying is greater than its downside threshold level, you would receive the stated principal amount, plus a contingent quarterly payment with respect to the final determination date. Your payment at maturity is calculated as follows:

In this example, although the final share price of the worst performing underlying represents a 15% decline from its initial share price, because the final share price of the worst performing underlying is greater than or equal to its downside threshold level, you would receive the stated principal amount plus the contingent quarterly payment, equal to a total payment of \$10.2075 per security at maturity.

- In Example 5, the closing price of at least one underlying is below its downside threshold level on each of the 1st through the 11th determination date. As a result, the contingent quarterly payment is not payable for any of those determination dates. At maturity, because the final share price of the worst performing underlying is less than its downside threshold level, but greater than or equal to its principal barrier level, you would receive the stated principal amount at maturity.
- In this example, although the final share price of the worst performing underlying represents a 32% decline from its initial share price, because the final share price of the worst performing underlying is greater than or equal to its principal barrier level, you would receive the stated principal amount at maturity.



Investor Suitability

The securities may be suitable for you if:

- You believe that the closing price of each underlying will be equal to or greater than its downside threshold level on one or more of the determination dates, and not below its principal barrier level on the final determination date.
- You are willing to make an investment that is potentially exposed to downside performance of the worst performing underlying on a 1-to-1 basis if its final share price is less than the downside threshold level.
- You understand that you may not receive any contingent quarterly payments.
- You are willing to hold the securities that will be automatically called on any of the second through eleventh determination dates on which the closing price of each underlying is at or above its initial share price.
- You are willing to be exposed to the possibility of early redemption.
- You are willing to invest in securities, the maximum potential return of which is limited to any contingent quarterly payments payable on the securities.

Risks Relating to the Structure or Features of the Securities

- You may lose your entire initial investment. The securities do not guarantee any return of principal. The securities differ from ordinary debt securities in that we will not necessarily pay the full principal amount of the securities at maturity. HSBC will only pay you the principal amount of your securities at maturity if the securities have not been automatically redeemed prior to maturity and the final share price of each underlying is greater than or equal to its principal barrier level. 




