GENERAL

This pricing supplement relates to a single offering of securities linked to the Reference Asset identified on the cover page. PAYMENT AT MATURITY

On the Maturity Date, for each security you hold, we will pay you the Final Settlement Value, which is an amount in cash, as described below:

If the Reference Return is greater than or equal to zero, you will receive a cash payment on the Maturity Date, per \$1,000 Principal Amount of securities, equal to the lesser of:

- (a) \$1,000 + (\$1,000 × Reference Return × Upside Participation Rate); and
- (b) \$1,000 + (\$1,000 × Maximum Cap).

The following examples indicate how the Final Settlement Value would be calculated with respect to a hypothetical \$1,000 investment in the securities. The numbers appearing in the examples below have been rounded for ease of analysis.

Example 1: The Official Closing Level of the Reference Asset on the Final Valuation Date is 1,316.90.

Because the Initial Level is 1,254.19 and the Final Level is 1,316.90, the Reference Return is 5.00%, calculated as follows:

Here, the Reference Return is 5.00%. Because the Reference Return is positive, and such Reference Return multiplied by the Upside Participation Rate is less than the Maximum Cap, the Final Settlement Value would be \$1,150.00 per \$1,000 Principal Amount of securities, calculated as follows:

\$1,000 + (\$1,000 × Reference Return × Upside Participation Rate) = \$1,000 + (\$1,000 × 5.00% × 300%) = \$1,150.00

Example 1 shows that you will receive the return of your principal investment plus a return equal to the Reference Return multiplied by 300% when the Reference Return is positive and such Reference Return multiplied by the Upside Participation Rate is equal to or less than the Maximum Cap.

Example 2: The Official Closing Level of the Reference Asset on the Final Valuation Date is 1,442.32.

Because the Initial Level is 1,254.19 and the Final Level is 1,442.32, the Reference Return is 15.00%, calculated as follows:

(1,442.32 - 1,254.19) / 1,254.19 = 15.00%

Here, the Reference Return is 15.00%. Because the Reference Return is positive, and such Reference Return multiplied by the Upside Participation Rate is greater than the Maximum Cap, the Final Settlement Value would be \$1,285.00 per \$1,000 Principal Amount of securities, calculated as follows:

\$1,000 + (\$1,000 × Maximum Cap) = \$1,000 + (\$1,000 × 28.50%) = \$1,285.00

Example 2 shows that you will receive the return of your principal investment plus a return equal to the Maximum Cap when the Reference Return is positive and such Reference Return multiplied by the Upside Participation Rate exceeds the Maximum Cap.

Example 3: The Official Closing Level of the Reference Asset on the Final Valuation Date is 877.93.

Because the Initial Level is 1,254.19 and the Final Level is 877.93, the Reference Return is -30.00%, calculated as follows:

Here, the Reference Return is -30.00%. Because the Reference Return is less than the zero, the Final Settlement Value would be \$700.00 per \$1,000 Principal Amount of securities, calculated as follows:
