PAYMENT AT MATURITY

On the Maturity Date, for each security you hold, we will pay you the Final Settlement Value, which is an amount in cash, as described below:

If the Reference Return is greater than or equal to zero, you will receive a cash payment on the Maturity Date, per \$1,000 Principal Amount of securities, equal to the greater of:

(a) \$1,000 + (\$1,000 × Reference Return); and

(b) \$1,000 + (\$1,000 × Minimum Upside Return).

If the Reference Return is less than zero but greater than or equal to the Buffer Level, you will receive \$1,000 per \$1,000 Principal Amount of securities (zero return).

ILLUSTRATIVE EXAMPLES

The following examples indicate how the Final Settlement Value would be calculated with respect to a hypothetical \$1,000 investment in the securities.

Example 1: The level of the Reference Asset increases from the Initial Level of 1,443.69 to a Final Level of 1,515.87.

Reference Return:	5.00%
Final Settlement Value:	\$1,100.00

Because the Reference Return is positive, and such Reference Return is less than the hypothetical Minimum Upside Return, the investor receives the Minimum Upside Return and the Final Settlement Value would be \$1,100.00 per \$1,000 Principal Amount of securities, calculated as follows:

\$1,000 + (\$1,000 × Minimum Upside Return) = \$1,000 + (\$1,000 × 10.00%) = \$1,100.00

Example 1 shows that you will benefit from the Minimum Upside Return at maturity when the Reference Return is positive but less than the Minimum Upside Return.

Example 2: The level of the Reference Asset increases from the Initial Level of 1,443.69 to a Final Level of 1,876.80.

Reference Return:	30.00%
Final Settlement Value:	\$1,300.00

Because the Reference Return is positive, and such Reference Return is greater than the Minimum Upside Return, the Final Settlement Value would be \$1,300.00 per \$1,000 Principal Amount of securities, calculated as follows:

Example 2 shows that you will receive the return of your principal investment plus a return equal to the Reference Return at maturity when the Reference Return is positive and greater than the Minimum Upside Return.

Example 3: The level of the Reference Asset decreases from the Initial Level of 1,443.69 to a Final Level of 1,371.51.

Reference Return:	-5.00%
Final Settlement Value:	\$1,000.00

Because the Reference Return is less than zero but greater than the Buffer Level of -10%, the Final Settlement Value would be \$1,000.00 per \$1,000 Principal Amount of securities (a zero return).

Example 4: The level of the Reference Asset decreases from the Initial Level of 1,443.69 to a Final Level of 866.21.

Reference Return:	-40.00%
Final Settlement Value:	\$700.00

Because the Reference Return is less than the Buffer Level of -10%, the Final Settlement Value would be \$700.00 per \$1,000 Principal Amount of securities, calculated as follows:

\$1,000 + [\$1,000 × (Reference Return + 10%)] = \$1,000 + [\$1,000 × (-40.00% + 10%)] = \$700.00

Description of the SPX


