

* Pursuant to a Share Exchange Agreement and Plan of Reorganization, US Patriot acquired from Chris Schwartz all of the capital stock of Metropolitan Recording, Inc., a Pennsylvania corporation ("Metropolitan Recording"). Metropolitan Recording owns all of the membership interests of Ruffnation Films LLC, a Pennsylvania liability company ("Ruffnation"), and all of the membership interests of Snipes Productions, LLC, a Pennsylvania limited liability company ("Snipes"). In connection with the share exchange, all of the issued and outstanding shares of capital stock of Metropolitan Recording were tendered by Chris Schwartz to US Patriot and US Patriot issued to Chris Schwartz 8,000,000 shares of US Patriot common stock and 1,000,000 shares of US Patriot Series A Convertible Stock. Each share of Series A Convertible Preferred Stock is convertible into 10 shares of common stock at the option of the holder and is entitled to 10 votes in all matters submitted to a vote of US Patriot shareholders. There was no monetary consideration exchanged in the transaction.


