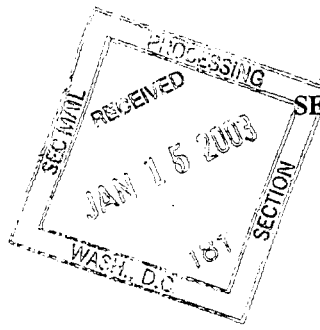



¹ The Partnership has paid its own organizational expenses and pays all investment-related expenses, such as commissions, research fees, custodial fees, etc. The General Partner pays for its own administrative expenses. The Management Company pays for the overhead expenses of the Partnership, such as office rent, supplies, secretarial services, etc. The Management Company is entitled to receive a management fee equal to .25% of the Partnership's net asset value as determined on the first day of each calendar quarter. The General Partner will receive a profit allocation equal to 10% of the amount by which the return received by a Limited Partner during any calendar year exceeds the return of the S&P 500 during such same calendar year. Such expenses, management fee, and profit allocation cannot be quantified at present.
