Answer to Items 5 and 6:

The Registrant, The Bryan-College Station Financial Holding Company ("Bryan-College Station"), was acquired by Texas United Bancshares, Inc., a Texas corporation ("Texas United"), on July 31, 2002. Bryan-College Station filed the initial Form TA-1 to register as the transfer agent for debentures ("Debentures") issued pursuant to an indenture ("Indenture") dated as of April 1, 1998 by and between Bryan-College Station and Harris Trust Company of New York ("Harris Trust"). However, pursuant to the terms of the Indenture, Harris Trust served as the registrar and transfer agent for the Debentures. The Bank of New York, as successor to Harris Trust, was the transfer agent for the Debentures as of July 31, 2002. The Debentures were paid on March 31, 2003.

All of the transfer agent functions for Texas United are performed by U.S. Stock Transfer Corporation and Texas United does not intend to perform any transfer agent functions in the future.

Answer to Item 9:

There is no successor transfer agent. The Bank of New York, as successor to Harris Trust Company of New York, was the transfer agent for the Debentures as of July 31, 2002. The Debentures were paid on March 31, 2003.

Answer to Item 10:

The books and records related to the Debentures are held at The Bank of New York, at 101 Barclay Street, 8th Floor, New York, New York 10286, Attn: Remo Reale. These books and records have been maintained by The Bank of New York and its predecessor, Harris Trust Company of New York, since the issuance of the Debentures on April 1, 1998.
