Answer to Item 5.

Orbitex Data Services, Inc. ("Orbitex") is a wholly owned subsidiary of Gemini Fund Services, Inc. ("Gemini"). Both Orbitex and Gemini are registered transfer agents with the Securities and Exchange Commission. As indicated on their respective TA-1 filings, both Gemini and Orbitex were acquired by NorthStar Financial Services Group, LLC in February 2003. Because both Orbitex and Gemini are related corporations and both are registered transfer agents, it is unnecessary to maintain both registrations and therefore effective May 2003, both companies have entered into a plan of merger to merge Orbitex into Gemini.

All work previously performed by registrant are now being carried out by registrant's parent company, Gemini Fund Services, Inc., a registered transfer agent pursuant to the Act. Gemini Fund Services, Inc.'s SEC File Number is 84-1964.
