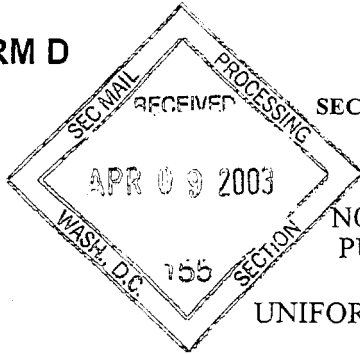

## Annex C.1

This Amendment to Form D relates to the sale and issuance of Series C Preferred Stock and the issuance of Common Stock upon conversion of the Series C Preferred Stock. There is no separate consideration for the conversion of the Series C Preferred Stock into Common Stock. Of the securities offered, shares of Series C Preferred Stock with an aggregate offering price of \$5,531,262 were sold at the initial closing that was the subject of the initial filing of the Form D. Shares of Series C Preferred Stock with an aggregate offering price of \$3,440,101 were sold at a second closing. The primary purpose of this Amendment to Form D is to report the sale of the additional shares of Series C Preferred Stock at the second closing.
