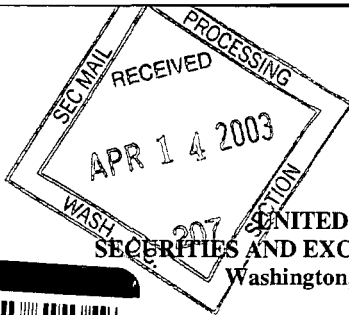

Part E and the Appendix need not be filed with the SEC.

Filing Fee: There is no federal filing fee.
