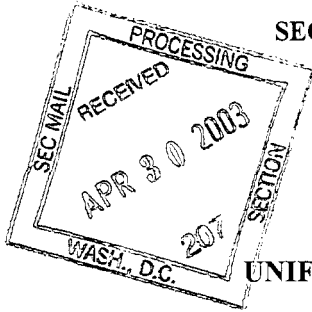





Note 1: Each 8% Convertible Subordinated Debenture has a face value of \$990 and is convertible at \$1.75 per share, after one year from the date of issuance. The Warrants are convertible at \$2.25 per share after one year from the date of issuance. Both the Debentures and the Warrants are redeemable by the corporation if certain share price targets are met.
