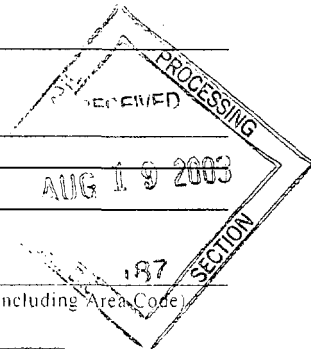

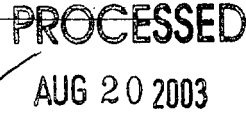



²Proceeds from the sale of these securities are being used to repay certain borrowings incurred in anticipation of this transaction.
