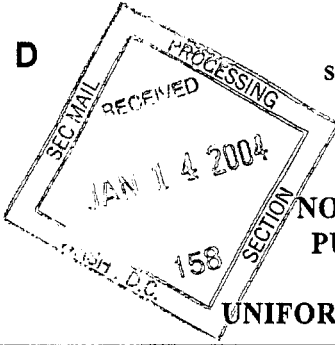

\* The general partner and its assignees will receive a quarterly cash fee in an amount equal to .025% of partner capital account balances and a quarterly incentive profit allocation equal to up to 10% of realized and unrealized limited partner capital account appreciation. In addition, the issuer will pay or reimburse AJD Capital, LLC and its affiliates approximately \$41,000 of organizational expenses and \$9,000 of offering expenses advanced on behalf of the issuer.
