C. OFFERING PRICE, NUMBER OF INVESTORS, EXPENSES AND USE OF PROCEEDS

¹ The Issuer has paid its own organizational expenses and pays all investment-related expenses, such as commissions, research fees, interest on mergin debt, borrowing charges on short sales, custodial fees, etc., as well as legal, audit and accounting expenses. The general partner pays for its own administrative expenses. The management company pays for the overhead expenses of the Issuer, such as office rent, supplies, secretarial services, etc. The management company is entitled to receive a management fee equal to .25% of the Issuer's net asset value as determined on the first day of each calendar quarter. The general partner will receive a profit allocation equal to 10% of the amount by which the return received by a limited partner during any calendar year exceeds the return of the S&P 500 during such same calendar year. Such expenses, management fee, and profit allocation cannot be quantified at present.
