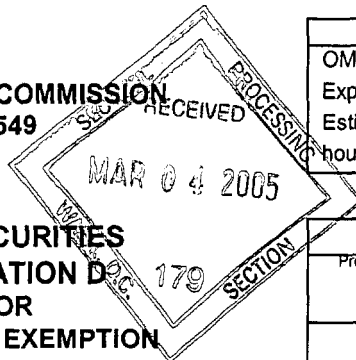

## EXHIBIT A

Mihaljevic Partners LP (the "Partnership") is a private investment fund formed to pool the assets of its investors for the purpose of investing, directly or indirectly, in a wide variety of securities and other financial instruments. The Partnership is offering limited partnership interests on a continuous basis to qualified investors. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
