



EXHIBIT A

The Prudent Global Natural Resources Fund, LP (“Partnership”) is a limited partnership formed to pool investment funds of its investors for the purpose of investing and trading in a wide variety of securities and financial instruments, domestic and foreign, primarily focusing on publicly traded equity securities related to the natural resources sector. The Interests will be continuously offered at the sole discretion of the General Partner. Although there is no maximum or minimum aggregate amount of limited partnership interests which may be sold in this continuous offering, we have inserted the figure of \$100,000,000 in Part C(1) of Form D as a reasonable estimate of the aggregate offering price of such limited partnership interests.
