(1) Each Limited Partner pays a management fee to the General Partner equal to 0.25% of the Limited Partner's capital account as of the first day of each calendar quarter. The performance allocation will be made only if such appreciation increases the capital account to an amount in excess of such Limited Partner's capital contribution.
