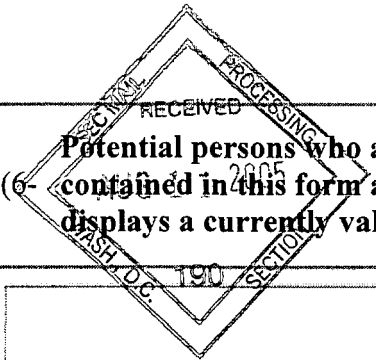

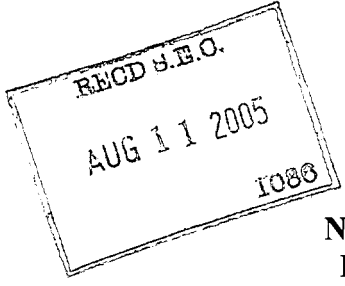

Exhibit A to the Form D of Abacus Mining & Exploration Corporation

A total of 1,681,666 units were sold in the offering at a price of \$0.15 CDN (\$0.12 U.S.) per unit. Each unit consists of one common share and one share purchase warrant, with each warrant entitling the holder to purchase one additional common share at a price of \$0.20 CDN (\$0.16 U.S.) until July 26, 2006.

A total of 140,000 of these units were sold in the United States to one accredited investor in the State of California. The remaining 1,541,666 units were sold in Canada and other foreign jurisdictions.

There were no commission or other fees paid.

The offering was effected in the United States pursuant to Regulation D and outside of the United States pursuant to Regulation S.
